### Understand the New Ratings

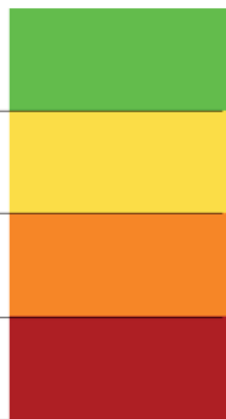
**Moderate:** Plan and prepare.

**Catastrophic:** For your survival, leave bushfire risk areas.

When there is minimal risk, Fire Danger Ratings will be set to '**No Rating**'.

## Prepare before disaster strikes

Everyone wants to help when the unthinkable happens and the community is thrust into an emergency such as a bushfire. Local government is at the forefront of managing emergencies and recovery and will need people in the community to help. But it is not as simple as putting up your hand, we need to make sure you are adequately inducted and register with Volunteering WA BEFORE you can assist.

Don't wait for disaster to strike, preregister as a volunteer through [Volunteering WA](#) so that if the

unthinkable happens in our community, you can act straight away.

## How fireproof is your plan?

One of the most critical and valuable things you can do is make a bushfire plan.

- When will you leave?
- What will you take?
- Where will you go?

## Local Emergency Management Arrangements (LEMA)

In accordance with Section 4 of the *Emergency Management Act 2005*, the Shire of Goomalling is required to review its Local Emergency Management Arrangements (LEMA) every five years. The LEMA is a community focused, coordinated approach to the management of all potential emergencies within a local government area.

The Local Emergency Management Committee (LEMC) comprises of key organisations within the community including schools, hospital, Department of Fire and Emergency Services (DFES), St John Ambulance, police, Department of Communities and the Shire of Goomalling. The LEMC meet on a regular basis to discuss, review and exercise the LEMA's effectiveness, including regional emergencies with surrounding local governments.

Shire of Goomalling's existing LEMA is due for review before the end of 2022. Council endorsed the updated LEMA at its meeting Wednesday 16 November 2022 and has submitted it to DFES for approval.

Council's current LEMA is available for review on the Shire of Goomalling website under [Plans](#).

With the review of our LEMA, it is a timely reminder for our community to **be prepared** for an emergency, here are some important things to consider:

1. Register with Volunteering WA (you won't have time to be inducted in case of an emergency, if you plan to help out, register now.)
2. Farmers – become a Farm Response Bushfire Brigade Member – complete your training to be eligible to receive "Vehicle Identifier Sticker" and receive Personal Protective Equipment.
3. Prepare a personal emergency evacuation kit
4. Follow Council's Facebook page and website
5. Store your important documents in water/fire proof containers
6. Make a plan for your pets and livestock

DFES has distributed the following guides for the current bushfire season and we've made them available on Council's website under [Emergency Services](#):

1. Burn Smart Guide for Landholder
2. Guidelines for Operating Private Equipment at Fires

In the unlikely event of an evacuation centre opening Council staff will accompany Department of Communities either within our Shire or elsewhere depending on the circumstance. Refer to the attached information sheets developed by Department of Communities as guide for your own emergency evacuation preparedness.

## Emergency Services information sheet

### Emergency Kits

#### Essential items

A well prepared emergency kit should consider the following items:

- water in sealed containers (10 litres per person for three days)
- portable, battery operated radio
- torch
- first aid kit
- Prescriptions, medications, sanitary products, toiletries and handywipes
- special needs for infants, aged and people with disabilities
- spare clothing including strong shoes, broad brimmed hat, and leather gloves
- waterproof ponchos
- blankets, towels
- sunscreen
- sleeping bags
- mobile phone and charger or phone card
- extra car and house keys
- multi-functional pocket knife
- canned food, tea, coffee, powdered milk
- can opener and utensils
- waterproof matches
- strong plastic bags for important documents and personal items
- emergency contacts
- family and friend contact details
- books, playing cards or games
- credit cards, key cards and money

#### First aid kit

Use a well sealed container for your first aid kit. A well stocked kit should consider the following essential items:

- non-stick dressings
- bandages
- sterile gauze pads
- bandaids
- antiseptic cream
- iodine
- saline solution
- pain relief
- surgical tape
- scissors
- hypothermic blanket
- Waterproof matches.

Pre-prepared first aid kits are available from pharmacies, some emergency service organisations and online. They can be tailor made to suit your specific needs.

### Storing key documents

In case of an emergency, store important documents in a fire and waterproof container or safe deposit box.

Review your insurance policies to ensure they are current and adequate.

If you keep documents in your home, try to take them with you if you evacuate.

It is recommended you keep originals and copies of documents at an alternate, secure location.

Some of the documents you should protect include:

- birth, death and marriage certificates
- mortgage/property deeds
- insurance policies
- banking details
- passport
- will and power of attorney documents
- important medical records
- insurance and letters of authenticity for art and jewellery
- back up of important computer stored information.

### Storage options

#### Safe deposit box

Banks rent safety deposit boxes for safe and secure storage of important documents and valuables.

### Fire and water proof containers (evacuation boxes)

Evacuation boxes should also include a small amount of cash, a phone card and a list of emergency phone numbers.

Your local emergency service centre or insurance company may provide fire and waterproof containers which you may also find at your local hardware or camping supplier.

### Useful tips

Photocopy each document and photograph valuables such as jewellery and art. Keep these copies in a fire and waterproof container at home or in an alternate, secure location.

Make a list of your possessions, including model and serial numbers of goods for insurance or tax purposes. Put one copy of the list in your evacuation box and another in your safe deposit box.

Photocopy receipts of valuable items and keep originals in safe deposit box. The contents of safe deposit boxes and evacuation boxes should be reviewed and updated regularly.

### Pet care

#### Evacuating pets

Animals are the responsibility of their owners at all times, including in emergencies.

Evacuation centres will not accept pets other than assistance animals due to health and safety risks.

Owners are advised to plan ahead for the safety and welfare of their pets, horses and livestock (farm animals) well before disaster strikes.

The following information is designed to give pet owners throughout the State useful tips to guide them through the pet evacuation plan.

#### Plan for pets

When planning your own response to an emergency evacuation make sure you consider how pets will be managed.

Some factors to consider are:

- do you intend to stay or leave your property when a warning is issued?
- either way, at what point in the warning will you relocate your pets to a delegated, safer area?
- check with your local council or relevant emergency related agency whether a pet contingency plan is already in place
- coordinate a pet evacuation plan with your neighbours, friends and or relatives
- ensure your pets are properly identified and their routine vaccinations and all tags and registrations are up to date
- include the phone numbers of your vet, local animal welfare agency and the local ranger.

#### After a disaster

Following an emergency or disaster animals can be disoriented, frightened or aggressive.

If an animal is missing after an emergency or disaster, owners should check with their local pound, animal shelter or boarding kennel.

Photographs of your animal and records of identification devices/numbers will help in the search effort.

#### Other hints and tips

- don't leave animals in vehicles
- in hot conditions provide extra water
- aviaries should be fitted with overhead sprinklers for use in fires
- report details of injured native animals.

## Community Notice - Support services

Recent tragic events throughout the Shire have no doubt had a major effect on the entire community but particularly on close family and friends of those directly affected. We should also not forget our healthcare professionals and volunteers, and the bushfires volunteers who have worked so hard to save lives and assets in these most trying of times with a number of incidents taking place over the last couple of months.

With this in mind a critical incident or potentially traumatic event is any event that has a stressful impact large enough to overwhelm your usual coping strategies. Some common emotional reactions include feeling frightened, shocked, numb, sad, guilty, frustrated, angry or helpless.

These reactions are normal, and in most cases, will gradually become less intense after a few weeks. For some people, these reactions can last longer and start interfering with their physical and psychological well-being and impact their ability to function

effectively, undertake their normal work and manage their personal commitments.

Each and every one of us can be affected by these recent incidents and it is important for our mental health that if you feel the need to talk to someone regarding the experiences of the last few weeks, that you do so, with any of the following services.

**Regional Men's Health** is happy to take referrals either self-referred or through the Shire or our health services and their contact number is **9690 2277** or if you make contact with us at the Shire, we will try arrange for someone to contact you.

More generalised assistance can be accessed through **Rural Aid Mental Health and Counselling service on 1300 175 594** and there is also assistance available through **Lifeline on 13 11 14 for crisis management and suicide prevention**

All of these services including the DFES Wellness Service for volunteers are provided on a strictly confidential basis.

## Wheatbelt Revegetation Program Land Purchases

Main Roads is seeking to buy portions of land adjacent to State roads for revegetation purposes.

There are a number of upgrades planned for roads within the Wheatbelt, which will require the removal of native vegetation that, in some cases, is protected by both State and Commonwealth legislation. The purpose of the land acquisitions and revegetation is to "offset" the future residual loss of this vegetation.

Main Roads is ideally looking for cleared farming land immediately adjoining the road reserves of State roads. The land should be 50 to 100 metres wide and more than one kilometre long, and (preferably) linking remnant vegetation. It is intended that any land acquired would be dedicated as road reserve.

## Bushfire Service (Brigade) Reform

Over the last 12 months the Shire has been working to reform its Bush Fire Service (BFS). Key measures include minimum training standards for members and the designated whole of Shire Farm Response Brigade. The Shire has spent 2022 working to reallocate existing members to their most appropriate brigade and provide relevant training to members.

As awareness of this process has increased in the community the Shire is receiving increased membership enquiries and as we head into 2023 we look forward to welcoming new members.

Prospective members are first requested to consider how they are likely to interact with the BFS, that is:

- a) as a Settlement Brigade Member (with Konnongorring, Jennacubbine or Goomalling Central) operating dedicated fire appliances; or
- b) as a Farm Response Brigade Member operating your own/private firefighting equipment.

- All members will need to complete a membership application form, available from the Shire.
- All members will need to attend the training required for their respective brigade membership type,
  - Settlement Brigade Members require two, two day courses that will commence late March at regional locations (including Northam and Toodyay)
  - Farm Response Members require a single day course held locally, commencing early February (or earlier if demand requires).

In addition, members receive full issue of Personal Protective Equipment (PPE) and will receive Shire BFS turnout messages from DFES.

## Refuse Site Closure during Harvest Bans

Effective as of 2022 bushfire season, the Goomalling Refuse site will be closed during a Council imposed harvest ban, due to its proximity to bush land, reducing the risk and enabling bush fire volunteers to concentrate on bushfire threats throughout the shire without the added complication of a tip fire. If the ban happens to fall on Avon Waste rubbish collection it will not impact the service.

## High Street shared pathway

Western Australian Bicycle Network (WABN) funded the installation of a new shared (2.5m wide) concrete pathway on High Street between Throssell and James Streets.

The project provides residents on the south side of High Street with shared pathway access, connecting them to the rest of the pathway network enabling better access to community services and facilities.

Other pathways within the network continue to get patch repairs on an ongoing basis, with the crew most recently on Forward Street.



## Netball Court Lights

Goomalling Netball Club were successful with two grant applications to Netball WA and CSRFF – Lighting for the replacement of the existing lights with new 200Lux LED sports lights.

Works will commence in January ready for the 2023 season.

## Cricket pitch

Three new clay wickets have been installed at the recreation ground funded by the Goomalling Cricket Club which replaces the two wicket set-up that had reached end of life.

## Road works

Road crew continue the widening and base preparation of Meckering Road ready for the new seal.

Meckering Road will remain unsealed between Patterson Road and Sadler Road until after Christmas closure when works recommence.

There has been significant investment in patching washouts and potholes throughout the shire. Any repairs should be reported to the works manager ASAP to enable repair before the Christmas closure.

## Lockyer Street shared pathway

Department of Transport is currently reviewing Council's reserve project for possible funding. The project will see the installation of a new shared pathway on Lockyer Street (NE) between Railway Terrace and Quinlan Streets and, facilitate connection to Railway Terrace and Quinlan Street enabling access to the recreation and shopping precinct for those residents.

## CBH Grass Roots Leadership Short Course

Delivered by the [Australian Institute of Management WA and University of WA Business School's Executive Education](#), the highly regarded Grass Roots Leadership Short Course is designed for people living and working in regional WA who want to develop their leadership skills and become more effective, influential, and engaging leaders.

The two-module course supports participants to analyse their leadership capabilities and develop a deeper understanding of what makes an effective and engaging leader. Over four days participants will have the opportunity to explore authentic and resilient leadership, build the confidence and tools needed to communicate with influence, and develop strategies to engage others in change.

An initiative of the [CBH Growers Advisory Council](#), the short course is part of the co-operative's Regional Capacity Building Program which aims to further strengthen regional leadership capacity and to support Western Australian growers to nominate for leadership positions within community and industry.

As such, the Grass Roots Leadership Program is heavily subsidised by CBH with participants required to contribute a \$400 fee and cover their own travel costs. All other costs including course materials, meals, accommodation, and course facilitation by an AIM/UWA facilitator are included.

## Sea Containers

If you wish to site a sea container on any property within the Shire of Goomalling you will require planning consent from the Council, regardless of the zoning of the lot. The Council does not consider a sea container an "outbuilding" or a "minor structure" and as such it is not exempted from development approval by the Local Government.

Generally, for lots within the townsite, approval will be given for a two year period depending on location, siting and condition of the container whereas rural zoned properties may receive ongoing approval if the container is used in conjunction with a farming activity or an on farm business undertaking.

## Caravan restricted use

The information below is a brief overview of the Caravan and Camping Regulations issued by the Department of Local Government, Sport & Culture in relation to restricted use of Caravans.

The Council's aim is to educate people about their obligations under the Act as caravan users and landholders. Council is required to enforce the Act.

### Why caravan use is restricted

Many people use caravans around the State, including for:

- personal circumstances
- tourism
- short term camping.

It is important that people who use caravans do so in a safe and healthy manner. For this reason, WA legislation generally restricts the use of caravans to licenced caravan parks. Furthermore, caravan parks are required by law to supply a certain level of services and utilities to its customers.

If a person uses a caravan outside a licenced park without the correct approvals or exemptions, they risk committing an offence. This will be the case irrespective of whether the land is private property or public land.

### What are the exemptions?

People are permitted to use caravans outside of licenced caravan parks in the following circumstances:

#### Approved short-term stay

Approvals include:

- Up to 3 nights: approval required from the property owner.
- Up to 3 months: approval required from the property owner and the local government.
- Between 3 to 12 months in special circumstances: approval required from the property owner, local government and the Minister for Local Government.
- If the applicant is seeking to camp on a State or Federal reserve, consent may also be required from the authority who manages that land.

### Roadside emergency

A person may use a caravan on a roadside if their vehicle has broken down or they are unable to drive safely.

In order for this exemption to apply:

- there must be a legitimate emergency
- the vehicle must not cause a road hazard
- the vehicle must be moved as soon as it is safe to do so (if it is immobile, it should be towed away).

### Overnight rest stop

Many local governments and State highways provide overnight rest stops for the purposes of convenience and public safety.

These rest stops are clearly marked and no approval is required to use them. However, this is allowable for up to 24 consecutive hours only.

### Construction of residence

Construction of residential homes can often be delayed due for a variety of reasons. This can create difficulty especially for rural residents when alternative accommodation might be expensive or a long distance away.

Under the current legislation, a person may apply to a local government for permission to live in a caravan while a home is constructed on the property.

This approval can be granted:

- for a maximum of 12 months; and
- if the property is subject to an active building permit.

While it is possible for an exemption to be extended, any extension beyond 12 months will require the permission of the Minister for Local Government.

If a local government grants an exemption, they may make it subject to conditions. For example, the local government may require the applicant to have sufficient power, water, sewage and cooking facilities. The [caravan and camping regulations](#) detail the various duties, approvals and exemptions that may apply.
