## CEO's column

#### Roads

Over the recent months we have been focussing on the Meckering Road upgrade with clearing now complete. There will be some drainage issues for us to deal with and so during December there may

be traffic management in place. Unfortunately we are bound by contractor availability to undertake the works, but I will apologise in advance for any delays our farmers face through the upgrades.

We have also put out to tender works on the Calingiri Road related to a grant received of \$1M to upgrade this important commodity route. These roads may also both benefit from funding from the Wheatbelt Secondary Freight Network project in which we are partnering with the entire 42 Wheatbelt Councils to secure funding.

Council has applied for MRWA Black-Spot funding for the re-alignment and re-profiling of the Konnongorring West/Northam Pithara Road intersection. The project will elevate and level off the first 160 metres of that intersection and slightly alter the angle of entry.

In addition, we will complete the works on the Konnongorring West Road under the Roads to Recovery Program and provide some upgrade to the entry/exit point of the CBH facility.

#### **CBH Konnongorring**

Council has had some discussions with CBH with regard to a further upgrade of the Konnongorring Bin facility and there will likely be action at the site in the next few months. CBH also foreshadowed some further upgrade of the facility in future years and this is an exciting prospect. There may be a requirement to upgrade the rail crossing for this to have a greater positive effect and both Council and CBH will have discussions with ARC Infrastructure regarding this.

#### **Ovals**

You will have noticed that the ovals have had some work following the football season. The football oval has been cored and vertimowed and the hockey oval has been profiled and cored twice as well. In addition, the hockey oval has been top dressed with a mixture of compost and imported sand to help with organic matter into the soil makeup but also to ensure that the oval is flat and appropriate to play hockey on.

It has had a big effect on the hockey oval with the surface now growing well and looking as good as it ever has. We will likely do another profile on this oval next year or the year after and it should then be in excellent shape for many years to come.

#### Council

We welcome two new Councillors, Casey Butt and Brendon Wilkes into the fold. Their journey as Councillors has now commenced and all four newly elected Councillors will undertake mandatory training which will include 5 basic units:

- Serving on Council
- Understanding Financial Reports & Budgets
- Meeting Procedures
- Understanding Local Government
- Conflicts of Interest

These units will be essential for all newly elected Councillors to complete within the first 12 months of being in office and as refresher courses every time they are re-elected. This will add to the skills and knowledge that each brings to the Council.

Council will be reviewing a number of plans and strategies over the next 12 months. The Community Strategic Plan will be reviewed to ensure that it aligns with Council's expectations. We will review our housing and public buildings from an asset holding perspective (do we keep them or sell them), review the use of the buildings and what the costs of each is to maintain. Council will come up with longer term strategies and then seek public comment on these strategies.

We will also need to have a look at our Town Planning Scheme where there are some anomalies that should be dealt with. This will be a longer process as changes to the scheme take longer timeframes to address.

## **Electors Meeting**

In June we held the Annual Electors Meeting and the late timing was due to our Auditor prioritising other work for the Auditor General over our audit. This was disappointing but there was little we could do.

There was much discussion about our financial position and the attendees wanted answers and to the best of my ability I tried to answer all questions that were put.

Council was clearly disappointed with our true financial position and has since that time been working toward

improving our financial position. Potential sales of houses are in the pipeline, there has been a favourable change in insurance premiums, a likely increase in planning fees and the eventual refinancing of the loan portfolio will ease the financial constraints we currently work within.

#### Water

During the course of the year we have tried to manage our dams and water catchments in a more appropriate manner. We have done a lot of work with the catchment near the primary sewerage dam and behind the Triangle dam near the Golf Course. We have been testing water from the CBH dam and have worked out a "shandying" regime for that water, and we are looking at potentially applying for a clearing permit to upgrade the overgrown catchment across the road from the Triangle dam on the Calingiri Road, to increase the amount of water captured.

There are still ongoing small, but annoying problems with the Chlorination/Filtration plant. We are reviewing what we may be able to do to upgrade the filter heads to relieve this problem. Likewise, there are still a few niggles with the reticulation as well but these things are addressed as best we can with the resources available.

As many will have noticed, we do not have the water resources that we had last year and some have asked "what is plan B?". The only answer I can give at the moment is, there isn't and has never been a plan B.

To water the combined ovals consumes about 190,000 litres of water at each watering. That's about 8 semi loads of water for a single watering. Ideally, we would be watering the oval 4 times per week but currently do 3 programs and predominantly water the hockey oval from scheme. This is the only method we have at present of trying to extend the life of our water resources. We do have limited access to scheme water at the filtration plant but not enough to properly supplement our dam and treated water. There is no option at this time to use scheme water on the main oval.

So, the aim from here on is to maximise the capture of water in our dams, clean up the salty CBH dam and reseal the bottom of it against salt invasion and to generally manage our water resources better. If we can capture more water we will minimise the likelihood of running dry. We will also look at any water grants that become available to improve the systems and water capture that we currently have in place.

#### Work camp

I can't finish this column without paying tribute the work that we have had done by the Work Camp boys. Some of the work that they have undertaken for us includes the clean-up and painting of 37 Throssell Street, various footpath repairs around town and brick paying work.

In addition, the guys we have on static or PEP supplement our regular workforce and nothing is too much trouble for them. We thank them heartily for their contribution to our community.

## **Tennis Complex**

The bricks that were used for paving around the Tennis Pavilion have eroded severely over the years. We have managed to secure a fairly large quantity of commercial grade pavers to replace the paving at this facility. The original pavers are hollowing and creating a hazard. It is our intention to replace the pavers in the new year with the new stocks and the Work Camp boys will undertake this work for us.

#### General

Council is in the process of selling 40 Forrest Street to Nathan Beck and we congratulate him on what is a longer term commitment to Goomalling. We will also be reroofing 34 Eaton Street in the near future, and taking back the control of the Railway Station building.

Finally, I would like to thank all of my staff, inside and out, for the professional manner in which they are adapting to the many changes that are happening within the organisation.

Since coming on board, Dave Long, our Works Manager, has implemented changes to the work flows for our outside staff and they have responded really well. It is a credit to both them and Dave for the improvements we have seen in their performance.

The girls in the office have had to put up with a slightly grumpy boss who is trying to keep up with the many issues and changes that happen in our workplace. I couldn't ask for a better bunch – keep up the good work girls!

And lastly, as this is the last newsletter before Christmas, I would like to wish everyone in the Shire of Goomalling a happy and safe Christmas and New Year.

## Works Manager's column



### **Meckering Road**

Stage 2 of the Goomalling-Meckering Road upgrade will commence on Monday 9<sup>th</sup> December 2019, between the Ucarty and Patterson Road junctions.

Scope of works for this

section consists of drainage improvements with replacement of a major culvert.

Traffic management and traffic lights will be in place while works are being carried out; all attempts will be made to have traffic reduced to one trafficable lane with delays kept to a minimum, but expect periodic delays in travel times.

Council realises that the timing of works is not ideal, however due to contractors' work scheduling constraints, works must proceed at this time of year.

Anticipated completion by Friday 20 December.

#### **Unsealed roads**

Shire of Goomalling advises that the unsealed road network can deteriorate substantially during the harvest period and conditions can change rapidly.

Caution is advised when travelling on the unsealed road network — make sure you drive to the conditions.

Extra care should be taken at road intersections and junctions with the increased movement of heavy vehicles.

Dust is also a factor when following or approaching heavy haulage vehicles, once again caution should be taken when in these situations.

Council endeavours to keep the unsealed road network in as good a condition as possible during this period. If any damage to the network is noticed, please report this to the office or works manager as soon as convenient so repair works can be scheduled. Thank you.

## **Local Government election results**

On Saturday 19<sup>th</sup> October the Community had the opportunity to elect four members in the Goomalling Council election. Elections are held every two years in October and the Councillors elected will be in office for a period of four years. In two years time the other three Councillors will be up for election.

The Councillors in this election whose positions were contested were Councillors Haywood, Van Gelderen, Ryan and Bowen.

Of the total number of 701 electors who could have voted, 216 chose to vote. Of this 112 voted early, 3 absent votes were received and 101 voted on the day. Voter turnout was 30.8% which was on the low side of the historical State average.

## **Bike Plan**

Council was successful in the Department of Transport WA Bike Network funding to update its Bike Plan.

The Bike Plan will aim to address gaps in the shared pathway network throughout town, ensure connectivity to schools, recreation and shopping precincts.

Planning is an essential prerequisite to attract future funding through the Department of Transport funding pool.

At Council's ordinary meeting on 20 November 2019, they considered the three proposals that were within the set budget and resolved to award the project to GTA Consultants.

Consultation plans and project scope will be refined during the engagement process, with planning expected to commence in December.

## **Blue Tree Project**



Blue Tree Project's mission is "to help spark difficult conversations and encourage people to speak-up when battling mental health concerns.

By spreading the paint and spreading the message that "it's OK to not be OK", we can help break down the stigma that's still largely attached to mental health"

On Friday 25 October a team of passionate community members painted a tree blue on the Goomalling-Wyalkatchem Road approximately 1.5km from town to share that message.

To further spread the message Goomalling Mental Surgery has a mental health display where you can get free Beyond Blue resources and learn a little bit about mental health.

## Tennis/netball courts resurfacing

Acrylic based surfaces have a life span of between 8 to 10 years, our multipurpose courts were last resurfaced in 2009 which means they've reach their end of life. There are significant cracks and wear and tear that need immediate remedial works.

The resurfacing process will strip back the old acrylic surface and apply new layers of Plexipave® acrylic, including grinding cracks to the end of the fracture and refilling with expandable acrylic to prevent recracking.

Council sought expressions of interest from Tennis West preferred suppliers to resurface the tennis/multipurpose courts. Sports Surfaces were awarded the contract for \$47,670 (ex GST) and will commence work on 6 January 2020.

Goomalling Tennis Club contributed \$15,000 and Goomalling Netball Club \$5000 towards the project.

## **Moma Movies & Mingle**

Moma solar lighting specialists won the contract in the Safer Communities Project to install solar security lighting at the recreation hub.

Saturday 23 November, Moma visited Goomalling to inspect the lights at night and mingle with the community. Gi and Coco enjoyed a meal at the Goomalling Sport & Community Centre, put \$300 on the bar on behalf of Moma, and funded the Copyright Licence for the movie Aladdin that was played on the big screen.

## Hockey field levelling

Since refurbishment in 2017, the hockey field has struggled with dry hot summers. Lack of water whilst it was in early stages of growth lead to a patchy, uneven surface.

Following the close of the 2019 hockey season, the Shire contracted Turf Care Services to re-profile, core and top dress the field with imported soil and organic compost. Turf Care's works combined with being watered during its prime growing time has resulted in a flourishing field.

Turf Care also cored the Football oval and provided a second coring of the hockey field free of charge.

## Lions recycling changes

We can now <u>only</u> recycle newspapers, aluminium cans, car/truck batteries, radiators, non-ferrous metals and clean milk bottles <u>without</u> tops.

The 8<sup>th</sup> of December 2019 will be or last kerbside pickup.

Unfortunately, we have to ask that only clean milk bottles & aluminium cans, newspapers, batteries and non-ferrous metals are left at the White Street depot.

We sincerely thank you all for your co-operation and assistance now and in the past. Hopefully we can find some markets and new outlets in the New Year and we will all be able to move forward from there with the Container Deposit Scheme to be implemented in 2020.

## **Container Deposit Scheme - Refund Points required**

From June 2020, Western Australians will be able to return eligible beverage containers for a 10-cent refund. **Containers for Change** is WA's new recycling scheme to reduce litter, improve recycling efforts, and get everyone involved in keeping our state beautiful.

After the initial request for applications to become a Refund Point there are various (mainly rural/small) towns where refund points are still required, and Goomalling is one of them.

## **Associations Act 2015 - implications for clubs**

#### After the transition period...

All incorporated associations and clubs were given three years to review and update their rules to comply with the Act. This Transition Period ended on 30 June 2019.

If you have not updated your rules, it does not mean that the document has expired or is invalid. Instead, the relevant clauses from the Prescribed Model Rules are deemed to apply if any of the <u>Schedule 1</u> requirements are missing from your rules.

To remove any uncertainty, please review your rules now if you have not done so already. A step by step guide and other useful resources are available on the <u>DMIRS website</u>.

#### Have you held your AGM?

There are three actions that all incorporated associations and clubs must do **every year** within six months after the end of their financial year:

- hold an Annual General Meeting (AGM);
- prepare financial report/statements which are presented at the AGM; and
- lodge an <u>Associations Information Statement</u> with Consumer Protection.

The financial year for many incorporated associations and clubs ends on 30 June so these organisations have until 31 December 2019 to meet these obligations. If the AGM cannot be held within the timeframe required by the Act an extension can be requested.

## Fire Season is upon us

## **Prohibited Burning Period has commenced**

The **Prohibited** Burning Period runs from 1 November 2019 to 14 February 2020. These dates may be varied by the Shire of Goomalling depending on seasonal conditions.

No burning is allowed for any reason during the prohibited period. This includes the burning of garden refuse and open cooking or camp fires.

## Fire Breaks need to be in place

As a landowner or occupier you are required under the Bush Fire Act 1954 and the Shire of Goomalling's local laws to carry out fire prevention work on your property. All properties were required to comply with the Shire of Goomalling Fire Break Order by 31 October 2019 and these fire breaks are to be maintained through to 31 March 2020. Authorised officers will carry out property inspections to ensure compliance with the requirements of this order.



Vegetation is to be kept below 75mm in height and all flammable material to be removed. Further information relating to the above can be found on the Shire website in the Emergency Services section.

#### **Total Fire Bans**

A Total Fire Ban may be declared by the Department of Fire and Emergency Services (DFES) when severe weather conditions or widespread fires are seriously stretching resources within the region or across the state.

When a Total Fire Ban is declared it is illegal to do anything that may start a fire. However, harvesting and normal farming practices are exempt during a Total Fire ban.

## **Harvest, Vehicle Movement & Hot Works Bans**

A harvest, vehicle movement or hot works ban may be declared by the Shire during the Restricted or Prohibited Burning Period. The Shire of Goomalling will determine the need for a ban and advertise the ban on ABC Radio and via the Shire's SMS service.

There is an automatic ban on all harvesting, vehicle movement and hot works on all public holidays including: Christmas Day, Boxing Day, New Year's Day and Australia Day.

A harvest ban is defined as a ban on all harvesting operations on all properties within the Shire of Goomalling. A vehicle movement ban is defined as a ban on all vehicle movements on properties within the Shire of Goomalling except for the essential watering of stock, using a diesel powered vehicle only and Emergency Services Vehicles. A hot works ban is defined as a ban on the outdoor use of all welding, grinding and abrasive tools. These bans apply to ALL properties within the Shire of Goomalling.

## Disease carrying mosquitoes

In WA, mosquitoes can transmit Ross River virus, Barmah Forest virus, Kunjin virus. There is no cure or vaccine to protect against Australian mosquito-borne diseases. The only way to prevent infection is to avoid being bitten.

#### Common mosquito-borne diseases in South West WA

Common symptoms include:

- Skins rashes
- Painful or swollen joints
- Sore muscles
- Flu-like symptoms (fever, chills, headache)
- Tiredness or weakness

Symptoms can last for several weeks to months, and in some cases years.

**NOTE:** Where possible, avoid exposing your baby or child to mosquitoes. Consider staying indoors, using pram netting or dressing them in loose, long-sleeved clothing, socks and shoes.

#### Mosquito repellents for children

Under 12 months – repellents containing DEET or picaridin are NOT recommended From 12 months – repellents containing up to 10% DEET or picaridin can be used.

#### Application guidelines for children

- Do not allow children to apply repellent
- Apply repellent firstly to the hands of the carer and then spread evenly to exposed skin of the child.
- Avoid applying repellents to hands, near the eyes or mouth
- Do not apply repellent under clothing







## Wet wipes

Wet wipes are a major cause of sewer blockages. In recent times this issue has increased significantly in Goomalling.

While toilet paper starts breaking down almost immediately, the woven fabric of wet wipes doesn't. As they move through the system they collect fat, grease and other food debris. Eventually they bind together creating blockages in household pipes and sewer mains resulting in overflows to the surrounding areas.

This is even the case with those wipes that are labelled 'flushable'. The only thing that should go down the drain is human waste and toilet paper; everything else should go in the bin.



## JP's needed

We currently have only 3 Justices of the Peace in Goomalling, which is not many for a town this size.


Karate lesson are \$25.00 per month, discount fees apply for families with multiple members. Annual insurance fees apply.
