#### **WA Day**

Western Australia Day (formerly Foundation Day) commemorates the day that the first European settlers arrived in Western Australia to found the Swan River Colony on 1 June 1829. The colony struggled in its early years, in large part because of the poor land conditions for farming. Food shortages left the settlers close to starvation, and many fled the colony; by 1832 only 1,500 people remained. An economic depression in 1843 almost brought the colony to an end.

WA Day is officially celebrated on June 1, but the public holiday is observed on the first Monday in June. It's a day to celebrate all Western Australians, recognising our Aboriginal history, early European settlers and the many from all over the world who have made, and continue to make, Western Australia their home.

## **Wheatbelt Revegetation Program Land Purchases**

Main Roads is seeking to buy portions of land adjacent to State roads for revegetation purposes.

There are a number of upgrades planned for roads, particularly within the Wheatbelt and to a lesser extent, Great Southern regions of WA, which will require the removal of native vegetation that, in some cases, is protected by both State and Commonwealth legislation. The purpose of the land acquisitions and revegetation is to "offset" the future residual loss of this vegetation.

Main Roads is ideally looking for cleared farming land immediately adjoining the road reserves of

State roads. The land should be 50 to 100 metres wide and more than one kilometre long and (preferably) linking remnant vegetation. It is intended that any land acquired would be dedicated as road reserve.

## **Goomalling Community Opshop News**

#### **Activate Goomalling Funding allocations**

The Opshop has changed its process and no longer offers adhoc or on demand grants. The new grant program Activate Goomalling offers two grant rounds per year in April and September.

On May 26th the Goomalling Opshop Volunteer Committee, along with Natalie and Jessika as the Shire representatives, held their Grants Funding meeting and allocated the following funds:

#### **Goomalling Men's Shed**

The Men's Shed was broken into earlier this year. Unfortunately, a large number of tools and equipment were stolen and the Shedders have been left unable to fill some of their community commitments. It was unanimously decided to supply them with the full grant allowance of \$2000.

#### **Mortlock Sports Council**

\$835 was allocated to the Mortlock Sports Council towards the purchase of potted plants to improve the aesthetics of the Goomalling Sports and Community Centre.

#### **Back to Goomalling**

The 'Back to Goomalling' group was formed with the aim to bring together a wide range of people with a connection to Goomalling – whether through birth, school, work, family or friends – to reminisce, reconnect or connect and celebrate Goomalling's rich history and discover what it has to offer now.

Funding of \$1000 was allocated towards event promotion. Look out for the next Back to Goomalling Day in February 2023!

#### **Goomalling Primary School**

Goomalling Primary School P&C is seeking to upgrade and add to their Comprehension Strategy Boxes to allow for a smoother rotation and greater variety of reading material that is specifically designed to help students learn at their own pace and to their individual needs. \$1000 will go towards the purchase of Comprehension Strategies learning resources for the school.

#### **Volunteers**

The Goomalling Opshop Committee also welcomed their newest member Jo Freeman to the team. As a new member of the Goomalling community, she is a welcomed and much needed volunteer for our Shop to continue.

## **2022-23 Budget**

Over the coming year there are a number of funded projects that are scheduled to be completed, these include the Anstey Park redevelopment, upgrade of the Gumnuts toilets, roof replacement at the museum, path upgrade on High Street, hall ceiling upgrade and maintenance to the Old Road Board building. These projects are fully federal funded with some state funds included for the High Street project.

Council's draft budget at this stage has \$4M in capital allocated to roads and plant. The Council will hopefully review the proposed budget late in June with a view to adopting at the July 2022 meeting.

## Works department updates

#### **Road Maintenance**

On the unsealed road network the road crew have repaired or replaced signs and guide posts and removed unused school bus stop signs. Culverts have been inspected and cleaned out prior to winter.

After the severe weather event in March, a couple weeks were spent on removing silt and cleaning up the townstreets, back lanes and footpaths, and backfill wash outs in drainage lines and on verges. Removal of debris, cleaning out of culverts and grading wash outs and silt was also required on the roads surrounding Goomalling.

Cemetery maintenance, raking up leaves, limbs and refuse, and levelling wash outs in the surrounds. Reconstruction works on some burial sites that had been damaged by the heavy rain.

#### **Parks & Gardens**

End of season renovations have been carried out on the cricket pitch - vertimowing, heavy dethatch, seed bare areas, fertilise and top dress with clay. The football and hockey ovals were fertilised, top dressed on low areas and around sprinklers, and fields and courts prepared for winter sports dugouts installed, goals, line marking, marking out the licensed area.

White St dams - transfer water to chlorinator dam, Pump station 1 - Inspect and organise repairs after lightning strike issues. Pump station 2 maintenance after storm event.

#### **Building maintenance**

CWA - packed up items in preparation for demolition. The demolition works were held up waiting for power to be disconnected. We are now in the stage of removing all the wooden flooring, then continuing with removal of roof tiles etc.

Once the demolition is complete and the area cleaned up the next phase of the project will be the extension and upgrade of Anstey Park.

#### **Road Works**

Work has continued on the Goomalling-Calingiri Road with the reconstruction of gravel shoulders and drainage works in preparation for the pavement widening. The existing sub base has been cement stabilised with a gravel base course to 10m wide. Sealing works have been completed to an 8m width on straights and 9m on curves to complete works for this financial year.



Nesting hollows have been installed as part of the conditions of the clearing permit for Meckering Road to offset the loss of vegetation in line with the Revegetation Management Plan.



A 1100m section of the Konnongorring West Road has been reconstructed and sealed. This was a continuation of works to now bring the widened seal pavement out to 7m from the Northam-Pithara road West towards the shire boundary.

## **Goomalling Historical Society**


Goomalling sporting groups have been sent a letter by the Historical Society regarding donating historical documents and objects to the museum. This could be anything from photos or trophies, to minutes and

## **Pioneers' Pathway**

Pioneers' Pathway is hopping on board the digital tourism bandwagon. The organisation successfully applied for funding from the Regional Arts WA 21-CTA Experience Initiative WA to create a series of Storytowns podcasts for the towns along the Pioneers' Pathway self drive trail.





This project is being conducted in partnership with the North Eastern Wheatbelt Travel Association (NEWTRAVEL) for the towns along the Wheatbelt Way Drive Trail and will see a total of twelve 7-minute geolocated townscape podcasts created. It is anticipated that this product will be a marketing tool that will help to increase visitor numbers with memorable stories, add cultural relevance and legacy, reveal unknown stories and facts about the region, generate retention of visitors, as stories will travel - word of mouth.

Storytowns' geo-located podcasts showcase and promote what the town or region has to offer such as businesses, attractions and events. The podcasts are designed to be an immersive and entertaining experience for the travelling tourist and locals alike.

The local podcast stories play automatically as visitors near a specific town or region increasing the chance of visitors stopping, exploring and spending more time there. Each 5-7 minute podcast describes the attraction and its history through casual interviews with locals/business owners/artists to uncover the personality of the town.

## **WA Plastics Ban explained**

#### Why is the ban being introduced?

Plastics have become a part of everyday life. They are inexpensive, convenient and used in many applications. However, many single-use plastics either end up as litter or landfill.

In 2019, the WA Government received over 9,400 submissions which indicated strong support for reducing the impacts of single-use plastics through a range of approaches including bans, product design, waste infrastructure, and widespread education.

In June 2021 the Government announced it was fast-tracking Western Australia's Plan for Plastics to commence in 2022.

#### What items are banned?

#### Banned from 1 July 2022:

- All plastic shopping bags with handles
- Disposable plastic utensils straws, stirrers and cutlery
- Disposable plastic foodware without lids plates, bowls and food containers
- Expanded polystyrene food containers and trays
- Balloon releases are also banned from 1 July 2022, however balloons are not banned.

#### Banned from 1 October 2022:

Disposable plastic cups for cold drinks

#### The ban applies to:

- conventional plastics made from fossil fuels, as well as plant-based plastics (limited exemptions apply)
- items made of plastic in whole or part (including linings, coatings and laminates)
- items sold or given away
- items supplied individually or in packets

#### The ban does not apply to:

items prepackaged offsite in food or beverage products (eg. straw attached to juice box)

- items intended for supply outside WA or business-to-business transport
- plastic straws provided in certain situations for people with a disability or healthcare need

#### Who does the ban apply to?

The ban applies to anyone who supplies prohibited items in Western Australia. Retail or hospitality businesses, manufacturers, suppliers, distributors and wholesalers as well as community groups, notfor-profits and fundraising events must not supply banned items. This includes items used as part of a service, for daily activities, or during events or fundraising activities.

Exemptions apply in certain settings to allow the supply of single-use plastic straws to people with a disability or healthcare need.

# **PLASTIC SHOPPING BAGS**

(of any thickness)



IMPORTANT: The 2022 ban replaces the previous ban on lightweight plastic shopping bags.



## **BANNED FROM 1 JULY 2022**

The ban now applies to all plastic shopping bags with handles The ban does not apply to: used to convey goods from a business including:

- shopping bags made from plastic film, of any thickness
- paper shopping bags that are plastic laminated
- the above bags used for home delivery or online sales

- plastic bags without handles
- produce bags
- sealed packaging (e.g. bread bags)
- other bags not intended for conveying goods from a retailer (e.g. bags for waste, nappies or dog waste)





## **ALTERNATIVES**

First, consider if you need to supply a bag. You could encourage customers to bring their own, reuse stock boxes or provide trolleys.

Then, consider using reusable bags made from fabrics such as cotton, jute, hessian, bamboo or hemp.

You can also use synthetic fabrics such as nylon, recycled PET, or polypropylene\*.

\*Non-woven polypropylene bags (like the green bag pictured below) must have stitched seams and a minimum weight of 90 gsm.

Any shopping bag with handles made from plastic or compostable plastic film is banned, regardless of reusability.

Finally, if you need a disposable option, you can use paper bags, but these must not have a plastic or cello laminate.

## **BANNED FROM 1 JULY 2022**

#### The ban applies to:

- disposable takeaway food containers made from expanded polystyrene (EPS) such as clamshells, plates and bowls.
- disposable trays made from EPS (such as fruit/vege trays)

#### The ban does not apply to:

- EPS trays which are solely used for raw meat or seafood
- EPS containers used for business-to-business transport
- EPS items which arrive to store in pre-packaged products (eg. EPS noodle cup, EPS trays packed by farmers)
- EPS cups are not banned at this stage





#### **ALTERNATIVES**

For EPS takeaway containers, consider if customers could bring their own takeaway food containers, or if you can introduce reusable options such as ceramic, metal, bamboo or glass containers.

If you do need disposable containers, consider uncoated paper, bamboo, aluminium or sugarcane pulp.

Also be aware of the rules for plates, bowls and containers (previous page).

For EPS trays, such as those used in fruit, vegetable or bakery packaging, consider displaying products without trays or packaging.

You could offer reusable produce bags, or trays made from paper or sugarcane pulp if needed.

You can use EPS trays for raw meat or seafood, however many retailers are switching to more recyclable plastics, such



#### **BALLOON RELEASES**

#### Banned from 1 July 2022

The ban applies to any person who releases a balloon inflated with gas that causes it to rise in the air, including an adult responsible for a child who releases the balloon or other persons, such as event organisers which permit balloons to be released.

The sale or supply of balloons is not banned or restricted.



## **Planning Approvals**

Development approval (or Planning Approval) may be required prior to commencing or carrying out development (works and/or use of land) within the Shire. A wide variety of activities are classified as development including changing the use of a premise from one activity to another activity.

## The installation of a sea container on any property is subject to planning approval.

A Planning Application must include:

- Application for Development form
- Site Plan To be drafted or drawn to scale or use Google Maps, Landgate Map Viewer or similar if includes a scale or shows measurements. Need to show the entire property, existing and proposed buildings and vehicle entrance and exit points.
- Floor Plan Could use previously prepared plans if the building is existing, otherwise draft or prepare plans to scale.
- Elevation Plan(s) Draft or prepare plans to scale including showing wall and roof heights or alternatively could use photographs if the building or structure is existing.
- Payment of the Planning Application fee The fee is payable when the application is lodged.

Subject to the proposed type, scale and location of the development, there may also be a need to provide the following:

- Covering letter outlining and justifying the proposal.
- Copy of the Certificate of Title and the Deposited Plan/Survey Plan;
- Bush Fire Attack Level (BAL assessment) or other form of bush fire assessment, if the property is within a Bush Fire Prone Area and you are proposing a house, short stay accommodation, other form of habitable building or it is a 'vulnerable land use'. To check, please visit:

maps.slip.wa.gov.au/landgate/bushfireprone;

Any other plan or information that the Shire may reasonably require to enable the application to be determined.

#### **Processing Your Planning Application**

#### **Initial check**

Assessment of the application will only commence once all required information is received. You may be asked to submit additional documents to complete the application.

#### Consultation

Based on the requirements set out in the Shire of Goomalling Town Planning Scheme No. 3 (the Scheme), or the type, scale and location of the proposed development, the Shire is required to seek comments on some Planning Applications before determining the application. This may require the Shire seeking comments from:

- Adjoining and nearby landowners;
- The broader community other stakeholders:
- Relevant State Government or other agencies.

Where the Scheme sets no requirement to seek comments and where a proposal is unlikely to have a detrimental impact on neighbours, the Shire may determine there is no requirement for consultation. Where consultation is required, it will be 14 days for most Planning Applications.

#### Determination

Most applications are determined under delegated authority by the Shire, where consistent with the Scheme, planning policies, other regulations and where no objections have been received through the consultation process.

If a bona fide objection is received on an or the application cannot application, determined under delegated authority for any other reason such as complexity of the application or variation(s) being sought, the application must then be presented to Council for determination.

The Shire's approval of a Planning Application is normally associated with conditions. The conditions need to be addressed and maintained by the applicant/landowner.

#### **Right of Review**

The Shire's determination of a Planning Application is subject to a Right of Review (appeal) to the State Administrative Tribunal.

## **Building Permits**

Planning approval is not a building permit. If your project has an element of construction you then need to also apply for a Building Permit. This fences, includes sheds, swimming pools, extensions to a building.

A Demolition Permit is required if you are demolishing an exisiting building.

To get a building permit you need to fill in the appropriate Application for a Building Permit form and provide all the necessary plans, documents and permits to the Shire.

Applications can either be submitted as a **Certified** Building Application, if plans are certified by a private certifier, or as an Uncertified Building Application, where Council's building surveyor assesses your plans and issues a Certificate of Design Compliance if everything is in order.

All commercial buildings or any buildings built on commercial zoned properties (including sheds on farms) are required to be pre-certified.

If you have a State Government provided water or sewage disposal service to your property, you must submit your plans and specifications to the Water Corporation for approval before lodging your Building Permit Application to Council. Fees to them will apply. Goomalling Shire owns the sewage scheme here but not the water supply. Therefore, you will have to submit plans to the Water Corporation if your property is supplied with their scheme water.

#### Required documents

When you submit your Building Application, you'll need to provide a number of permits, plans, receipts and other documents. Which documents you need depends on:

- the type of building, renovation or demolition,
- whether your project will affect your neighbours,
- where your project is and
- a number of other factors.

We've made a Building Application Checklist you can use to ensure you've got everything you need before you submit your application.

If Council is certifying the design, you will hear back from our Building Surveyor about your Building Permit within 25 working days. If you submitted a certified application, our Building Surveyor will respond within 10 working days.

If you don't submit all the necessary documents, Council's building surveyor will ask you for further information. You'll then have 21 days to supply these, after which the 25 (or 10) days restart.

If your building permit is approved your project can go ahead, subject to the **building conditions** and any notations placed on the approved plans.

Be aware that your building permit is only valid for If after that time your project is well advanced but isn't complete you can apply for an extension. If inadequate progress has been made you'll need to reapply for a building permit.

When in doubt about either planning approvals or building permits, please contact us for the most up to date information.

## Community garden update

The Goomalling Community Garden is looking lush and bountiful, thanks to the generous work of a handful of volunteers who are more than happy to share their gardening knowledge and experiences.

Produce ready for you to pick and eat now:

- **Capsicum** Cut stem close to capsicum to remove without damaging the plant.
- **Strawberries** Ready to pick when red.
- Silverbeet Pull off the outside leaves, leaving the centre to continue growing.
- **Sweet potatoes** you will need to dig around the bed of sweet potatoes. Please don't pull up the plant as it will keep growing and producing more sweet potatoes.

The following cool weather crops have been planted:

**Broad beans** Cauliflower Cabbage Broccoli Carrots **Potatoes** Silverbeet Celery

Snow peas

The summer crop of pumpkins was very successful, with a lot of butternuts produced, and quite a few small Jap pumpkins.



Sugarsnap peas and more snowpeas are being grown from seed and will be planted in the garden in the coming weeks.

We also have rhubarb, sage and rosemary plants, all of which were donated by the volunteers, and there is plenty of Italian parsley, which self seeds in the garden.

The volunteers are usually at the garden on a Monday morning, and visitors are welcome at all times. Please supervise children and be Covid safe. If you are interested in finding out more please contact Peta on 0467 895 811.

#### **Bush Fire Service News**

In the Autumn 2022 Newsletter, the Shire outlined several changes to its Bush Fire Service. These changes are required in order to meet the Work Health and Safety legislation now in force.

The process requires actions from all bush fire members to ensure ongoing membership. The main actions are:

#### 1. Membership Review

In February all existing members were written to (where membership postal records exist) requesting return of a membership confirmation form. This form is now due. If you are a member and have not yet returned your membership confirmation form to the Shire, it is requested you do this ASAP. Additional forms are available from the Shire administration office. The Shire would like to thank those who have completed and returned forms.

#### 2. Training

All members are required to meet a minimum training standard set by Council. Members who have completed their membership review form have been emailed details of their training requirements and scheduled dates. Training has now commenced - It is important that all members attend the required training.

The Shire of Goomalling recently received a grant from the Department of Fire and Emergency Services (DFES) for the installation of three fire emergency water tanks. The three tanks have been installed in Hulongine, Jennacubbine and Karranadgin. Each tank will hold 47,000ltrs each and will be plumbed so fire appliances can draft water, reducing turnaround compared to existing water sources.

Residents are reminded that these assets are for use for combating wildfire only, and are not a resource for any other use. The tanks will be locked for security with the Shire BFB fire appliance having key to access. All three sites will be fully operational prior to the commencement of the fire season. Locals are asked to keep a lookout for any suspicious activity at these tanks and report to the Shire.



## **Booking a Practical Driving Test**
