### CEO's column

#### Water

There have been lots of issues with water over the past few months. Since November we have been managing water use on the ovals with the Hockey oval being watered with scheme and the main oval with treated water. We have no ability to use scheme on the



main oval so we have to manage it differently. A couple weeks ago we were down to a few hundred mls of treated water. This is when an offer was made to Council to cart water from our main standpipe to the dam to help with watering the main oval. Although we are not allowed to provide water from the standpipes to other parties, we are able to use the water for this purpose as it is for our own use, but I'll talk more on that later.

Since then the 53mls of rain we had in town and the difference it has already made to the ovals, gardens and trees, has highlighted just how desperate we were for rain. As we all know, water from the sky is so much better!

There are investigations underway with regard to alternative water sources and while there is some way to go, we will need to find ways to fund them. Unfortunately Goomalling, and many of our neighbouring Councils, were not allocated funding through the Drought Communities Programme. I have since written to Melissa Price and also the Deputy Prime Minister reminding them that Goomalling has had below average rainfall for 7 of the last 10 years and that we too are doing it tough on the water front. We are hoping that should there be further funding made available that we may be a part of that round.

Back to the standpipes, last year Watercorp gave Council the option of closing standpipes to the general public or paying a fixed charge for each and a rate of about \$8.50 per KL for water onsold to the public. Depending on the size of the outlet and thus the flowrate, that charge varied from about \$2,200 to \$25,000 each year to provide water. In order to provide a reasonable flow rate would make the cost prohibitive.

In recent weeks I have been at a Rural Water Council Meeting, had a meeting with one area of Watercorp and am pursuing other Watercorp representatives to try and find a way to reduce the charges applicable so that we will

be able to help the farming community with water again. Without Watercorp reducing these charges, we would have to charge hundreds of dollars per KL to recoup the costs of these charges or reduce the flow rates to around 20 to 50 litres per minute. That is about 20 hours to fill a semi of water.

#### **Criminal acts**

Over the course of the summer we have had locks cut on standpipes and water stolen from the scheme. Council is required by Watercorp to have the standpipes locked and faces penalties if they are not. When people cut those locks and steal that water, it exposes Council to further costs, not just for the plates and locks, but the penalties as well. It is a criminal offence to remove the locks and steal the water.

In addition, the lock on the waste facility gate has also been cut and this too is a criminal offence. The locks are there for a reason, not the least for public safety. Council has had to purchase surveillance equipment to monitor the situation. If we do have footage of people taking water or damaging our property, we will prosecute.

### **Konnongorring West Road**

We are getting to the pointy end of the Konnongorring West project now. Council has commenced the western portion of the job which includes the entry to the bin and the upgrade of the single lane section beyond that which basically completes the project to within 20 metres of the rail crossing.

We are widening the road to 8m including a 500mm gravel shoulder each side (7m of seal, 8m if funding permits). The current seal width on the railway crossing is 5.8m so we are looking for Arc Infrastructure to widen their portion by 1.2m for the width of the rail corridor. We have had significant discussions with Arc Infrastructure as well as MRWA to try to find a compromise situation and some reasonable pricing for the work.

To date Council's upgrades to the road have totalled nearly \$0.5m and this year's existing commitment is a further \$235,000 which will include the entry interface upgrade. The re-alignment and elevation project for the Eastern side of the tracks and intersection with Northam-Pithara Road will add a further \$150K to \$200K to the project which tops the project out at over \$1M once the rail crossing is factored in.

### **Budget**

During the course of May and June, Council staff will be putting together the 2020/21 budget and if residents have requests to put forward now is the time to do so. Every proposal is considered but resources will determine which are successful or not.

### Audit 2018/19

We have just completed our first audit under the Auditor General. There are several issues that were picked up in the audit which will require the Council to make a report to the Minister for Local Government. This will also be published on our webpage once adopted by the Council and if available, be presented at the AGM of Electors on 6<sup>th</sup> April (see more p.11).

### **Corellas**

Corellas are a huge problem over much of the State and also interstate. These birds are really intelligent and learn quickly. Recently they have been causing significant damage to the oval, have chewed through the power cable at the Caravan Park and are denuding trees throughout the district. They are capable of pulling Tec screws from roofing and will chew through street light covers to get to the glue inside which gives them a high!

The birds are extremely noisy, are up at dawn and are causing trouble for many residents of our district. They have taken over habitat from other native birds and have forced Pink & Greys south to areas that they have rarely been seen in the past.

There have been a number of programs put in place Statewide to try control their numbers but at this stage nothing seems to work well. Their reproduction rate and their ability to recognise trapping stations make it very difficult.

At the recent WALGA zone meeting Councils of the Avon/Midland Zone have put forward a recommendation that WALGA attempt to convene a working group of Federal, State and Local Government representatives to tackle the problem. The issue has become something greater than Local Governments have the resources to deal with and there needs to be a willingness to look for more effective methods of control. Areas of national significance are being degraded by the sheer number of these birds. We will keep you posted as to what transpires.

# Works Manager's column



### **Parks & Gardens**

Our Parks & Gardens crew have been busy with the care and maintenance on all turf areas to keep to as good a standard as possible with the hot dry summer season we have had.

They have pruned and tidied many of the housing yards and parks/garden beds. Reticulation repairs and maintenance has required a lot of work during this time. Staff are also responsible for the clean-up of leaves, limbs and refuse on the main street, public areas and street verges which is carried out on a regular basis.

#### **Ovals**

Water management practises for the ovals have been in place since the beginning of November with watering only being carried out to a minimum due to the very low water levels in the storage dams at the beginning of summer.

Soil wetting agent has been applied on a regular basis to add to the water conservation methods as well. There were a few issues with the reticulation system in November and December which hindered the turf performance significantly.

The Football club volunteered to cart water into the main storage dam during February and without this occurring the dam would have been empty by the end of February or early March. Thank you to all those involved in doing this.

#### **Townsite**

Tree limbs overhanging the footpaths have been pruned. The Dowerin Work Camp crew have repaired the worst sections of the footpaths on various streets around town, which included ripping up and relaying the failed footpath sections. This has been a great cost saving for council with repairs being carried out to a good standard.

# **Buildings**

Some of the more major works carried out are a full clean and interior paint of 3 houses and new floor coverings in two of them, full interior paint of the opshop, and repairs to the ceiling around the stage area in the Town Hall with painting of the area to complete the works.

The work camp crew assisted us cleaning up the yards of vacated Shire houses, paving at the tennis complex and the caravan park, which are all major savings to Council.

### **Plumbing**

There have been many blockages and issues lately – many of these being caused by wet wipes being flushed. So we need to reiterate the message from our previous newsletter that wet wipes are **not** to be flushed, even those that are labelled 'flushable'. The only thing that should go down the drain is human waste and toilet paper; everything else should go in the bin.

The plumber has attended to these and also started a regular maintenance program when time permits of flushing main sewer lines and manholes to attempt to keep blockages to minimum.

#### **Town and Rural Maintenance Crew**

This crew has undertaken many maintenance jobs mainly on the rural roads and town streets as well as doing all works request deliveries etc.

Major works being carried out were repairing the signage and guide posts on an ongoing basis where required, and many rural roads have had minor tree pruning carried out on the worst of the overhanging limbs etc.

Yearly bridge maintenance works have been completed on Bolgart East, Yarramony and Wongamine bridges with further works to be completed in the cooler months.

Council also contracted out bitumen patching works on some of the sealed road network that was failing badly, the main areas concentrated on have been town streets, Bejoording, Oak Park, Bolgart East, Tyndall and Meckering Roads.

#### **Construction Crew**

Our Construction Crew have completed many maintenance works during the harvest and summer period. These mainly being the patching of sand holes during harvest.

Some of the more major jobs completed are sheeting of clay and rocky areas on Saddler Road; about 3kms of sheeting of sandy, clay and rocky sections on Patterson Road; 1.2kms of clay areas on Anderson Road; and the installation of a culvert in a low lying creek way and sheeting of clay areas on Ucarty road.

Current and upcoming projects the construction crew are working on are:

- Konnongorring West Road Reconstruction, widening and sealing of the section adjacent to the CBH bin. This will be widened to a sealed width of 7 to 8 m wide to negate future maintenance cost with edge fretting of the new seal. The intersection and first 160m of Konnongorring road from the Wongan Hills road is not included in these works as Council is seeking funding to assist with future upgrade works due the high cost nature to upgrade this section.
- Goomalling-Calingiri Road These works were outsourced to contractors through a tender process for the pavement repairs of failed

- bitumen section along most of the length of the road. These will be repaired by cement stabilisation works and two coat sealing of the repairs. Works are anticipated to commence mid March, weather permitting.
- Goomalling-Meckering Road Clearing and drainage works have now been completed with graveling and sealing works to be completed before the end of the financial year, weather permitting. It is anticipated works will resume again in late March or early April at the completion of the Konnongorring West works.

#### General

I would like to thank and congratulate all staff in all works departments on a great job being done during this time, especially over the very hot and dry summer months.

# **Bike Plan & Pathways Program**

We are pleased to inform you that the Shire of Goomalling has been successful in securing the following grant funding:

- \$18,500 in 2020-21 for design and construction of a new pathway on Bowen Street
- \$14,500 in 2021-22 for the design and construction of a new pathway on High Street


Construction of new pathways was recognised as a priority in Council's Bike Plan (2009). The project will be carried out over the next five financial years commencing 2020/21 to complete the 5 identified pathways.

Bowen Street was acknowledged as a key route to Goomalling Primary School from the eastern side of town as well as linking the hospital to the bicycle network. The design and construction of a 2.5m wide concrete shared pathway between the Forrest St and Hoddy St intersection is planned for the 2020/21 financial year. The proposed project will result in safer connection from the residential area to Goomalling Primary School and Goomalling Hospital.

The second stage of the pathways project is the portion of **High Street** between Throssell St and James St. High Street was identified as a key route to Goomalling Swimming Pool and Caravan Park; as well as to the recreation ground for those residing on the south western end of Throssell Street. This project completes the bicycle network in the central street of the townsite.

Council is currently also in the process of reviewing its **Bike Plan** in conjunction with GTA Consultants. The purpose of a local bike plan is to prioritise which routes require maintenance or establishment of new pathways, ensuring connectivity to schools, recreation and shopping precincts.

The draft version of the updated plan will be presented to the community for review at a **Community Consultation on Thursday 12<sup>th</sup> March**, from 3.00-5.00pm at the Goomalling Sport & Community Centre. Input from the community is a fundamental part of the review, as we want the plan to represent the community's current needs and priorities. **So come and have your say!** 



# **Recreation Ground upgrades**

### **Multipurpose Complex Paving**

Paving around the multipurpose complex had deteriorated due to condensation and rain exposure that eroded the bricks surface. Wheatbelt Workcamp assisted Council to replace paving with a more robust and less permeable style of brick that contrasts well aesthetically with the red brick walls. Thank you to the Wheatbelt Workcamp for their meticulous work ethic.



### **Tennis/Netball Court Resurfacing**

During February, the faded green courts were transformed into the striking blues, a signature of the Australian Open. The project took approximately a week to complete including cleaning the courts, intensive crack repairs (chiselled out completed and filled with fibreglass membranes to prevent further cracking),



priming and painting. The courts were able to be played on the day they finished painting, the ladies' midweek pennant team were the first to play on them.

The project was in the 2019/20 budget as part of asset maintenance, with contributions from both the Tennis and Netball Clubs. The contract for this project was won by Lynda & Clive Peckham, Sports Surfaces.

### **Hockey Light installation**

The final recreation ground upgrade for 2019/20 is installation of a sports LED light at the eastern end of the hockey field. This small project will alleviate the need to turn the tennis lights around during the winter months which currently costs \$5000 p.a. due to machinery hire. Lighting at both ends ensures that the wear and tear is evenly spread throughout the field instead of on one end, which historically has seen growth of grass inhibited in the D and goals on the western end.

The hockey lights conclude the recreation ground projects upgrades for 2019/20. Staff are currently working with the cricket club on projects for 2020/21 including relocation of the cricket nets in accordance with the recreation master plan and replacement of the turf cricket pitch. Council is assisting the club to submit an application in the WACA's facilities fund by 20 March.

# **Restricted Burning Period**

After a short extension due to dry conditions the Shire of Goomalling now entered the **Restricted** Burning Period on Tuesday 3<sup>rd</sup> March 2020.

**Permits** are required and will be issued only for stubble/grass for crop preparation purposes. Permits may be obtained via the Shire administration office. Holders of permits must comply with all permit conditions which include requirements around burn notifications, minimum supervision & firefighting resourcing and time periods for lighting of chaff piles.

The Restricted Burning Period runs until 29 March, subject to review. In previous years the RBP has been extended by 2-4 weeks depending on the conditions. This will be advised via the usual channels.

The burning of garden refuse is allowed between 6.00-11.00pm during the RBP; provided it is no larger than a wheelbarrow sized pile, a 5m firebreak is cleared, and a responsible person is in attendance until the fire is fully extinguished.

# TerraCycle® Recycling

TerraCycle® is an organisation that recycles waste streams that are difficult to recycle or aren't accepted in ordinary municipal waste collection.

The Goomalling Shire and Community Opshop are trialling collection of the following four waste streams:

- Beauty products
- Media storage (digital & analog)
- Pens, Pencils and Markers

These are items that we don't generally recognise as being recyclable, so it will take a change in mindset to create a new habit. You could collect them all in a plastic bag and bring it in to the Shire (or Opshop) when you do other jobs in town.

TerraCycle® offers several free recycling programs funded by brands and manufacturers, as well as Zero Waste Boxes available for purchase for different waste streams, allowing you to recycle almost any type of waste! Find out more on www.terracycle.com/en-AU.

Other convenient collection initiatives in town include:

- Mobile phones and accessories through MobileMuster satchels available at the Post Office
- Nespresso capsules collection box at CentralAg
- **Bottle tops** collected at opshop for charity that turns them into prosthetic limbs for children
- Used household batteries collection box at the Shire office
- Empty ink cartridges at the Post Office as well as Shire office.

Media storage including records, 8track tapes. cassette tapes, CDs, DVDs, Blu Ray discs, floppy disks, memory sticks and external hard drives.



### Pens, pencils & markers

Pens, pen caps, mechanical pencils. markers, marker caps, permanent markers, and permanent marker caps.



### **Beauty products**

make up, cosmetics packaging, brushes, hairbands, clips, shampoo and conditioner bottles

# **Recycling in Goomalling**

### **Lions Club recycling**

Due to changing market demands in the waste recycling sector, the Goomalling Lions Club has recently had to review and reduce on the materials they are able to collect and process.

The Lions' recycling depot on White Street can now only collect / accept:

- newspapers,
- aluminium cans,
- glass bottles,
- clean milk bottles <u>without</u> tops,
- car/truck batteries and radiators,
- non-ferrous metals.

### 'Containers for Change' Donation Point

From June this year the Lions Club depot will become a Donation Point through the Container Deposit Scheme (see more below) where you can drop off your eligible containers, as you would now.

The refund applicable to those containers will then be **donated** back into the community, just as has been the case up to now.

# **Container Deposit Scheme**

From 2 June 2020, Western Australians will be able to return eligible beverage containers for a 10-cent refund. **Containers for Change** is WA's new recycling scheme to reduce litter, improve recycling efforts, and get everyone involved in keeping our state beautiful.

The scheme targets beverage containers most commonly seen as litter. *Most aluminium, glass, plastic, steel and liquid paperboard beverage containers* are eligible for a refund. These items will display the refund mark, like the SA & NT mark that is already displayed.

Bottles that have contained milk, wine, pure spirits, concentrated cordial will <u>not</u> be eligible for a refund. Most of these however can still be recycled through existing kerbside collection or drop-off services.

### Kerbside collection of recyclables

Avon Waste is contracted to collect Council's ordinary waste and also offer recycling services with a fortnightly collection. Unlike domestic waste that is disposed of at our local refuse site, all recycling is transported back to their Recycling Transfer Station where it is pre-sorted before being transported to a Material Recovery Facility (MRF) in Perth for the further sorting and processing before being sent to markets both locally and overseas.

All material identified as recyclable would be collected in the 'yellow lid' wheelie bins, without the need to separate them.

Providing this service in Goomalling is in line with our objective to "create a zero waste culture amongst the community" as identified in our Strategic Community Plan and plays an important role in management of our waste.

The estimated cost to residents is \$85-100 per bin per year (inc. GST) to be charged on the rates notice. Council invites **public comment or feedback** on the proposed kerbside recycling service which we would hope to commence as of 1 July this year.


