The term for 3 of our current elected Councillors expires in October 2021, so if you want to make a difference in Goomalling and have a say in local decision making, why not consider standing for election.

Councillors play an important community leadership role creating policies and making decisions that affect what happens locally and they do this through consultation with the community.

What does it mean to be a Councillor?

Council's role within a Local Government

The Council works together with the community and Shire staff to create and implement the community's vision, strategic direction and values.

The Council's role is to:

- govern the local government's affairs;
- be responsible for the performance of the local government's functions;
- oversee the allocation of the local government's finances and resources; and
- determine the local government's policies.

The role of each Councillor

A councillor is a member of a team, shaping the district's future in consultation with the community.

Councillors:

- attend relevant training and workshops;
- represent the interests of electors, ratepayers and residents;
- provide leadership and guidance to the community;
- facilitate communication between the community and the council and vice versa;
- participate in decision making processes at meetings.

What is expected of a Councillor

Council members have a duty to attend all or most council meetings to ensure that electors are adequately represented. At their meetings Council:

- Approve and review Council policies;
- Set and adopt annual budget, and review finances through monthly reports;
- Review our strategic planning, to make sure it is meeting the changing needs of the community;
- Provide input on State and Federal issues;
- Vote on any other items or requests.

In Goomalling we hold 11 ordinary Council meetings, approx. 2-3 special meetings per year, and other functions or meetings as required. Meeting attendance fees are paid as a recognition of the amount of time and effort members must put into preparing for meetings.

Deciding whether or not to stand for council is a very personal choice. You need to consider your own circumstances and whether or not you think you are suited to the role, and if you are able to make the commitment in time and energy required to fulfil the role.

Nominations must be lodged with the Returning Officer at any time during the above period at the Shire administration office.

Nomination requirements

Candidates are required to lodge with the RETURNING OFFICER:

- A complete nomination in the prescribed form, signed and witnessed. This form is available from the Shire office.
- A single A4 profile not more than 800 characters, including spaces, containing biographical information about the proposed candidate and statements of the candidate's policies or beliefs.
- A nomination deposit of \$80 (cash, cheque, bank draft or postal order, or other mean subject to the Returning Officer approval).
- A recent passport-sized photograph (optional).

To nominate, every individual must complete the mandatory induction for prospective candidates course, available via the Department of Local Government, Sport and cultural Industries website at www.dlgsc.wa.gov.au

Where an agent lodges a nomination on a candidate's behalf, it must be in the prescribed form with a written authorisation signed by the candidate.

The documents may be hand delivered, posted, faxed or sent by electronic means to the Returning Officer and must be received by the close of nominations.

Anstey Park Revitalisation

The revitalisation project continues with the focus group meeting having made a number of suggestions regarding recognition of the CWA's use of the site, different types of structures and preferred soft fall options.

These suggestions will be considered within the context of available funding for the project as at this stage we only have a commitment for \$150,000 in funding approved through the Local Road & Community Infrastructure (LRCI) program (Federal Funding).

We will continue to seek other funding options; however, the timeframes will be restricted as this grant will need to be spent in this calendar year.

The CWA State Office has given approval to demolish their building, Council staff will carry out removal of

contents of the building which will be put in storage until the CWA State Office can go through it and collect items of value.

Council has been discussing the demolition stage of the project with Wheatbelt Workcamp to reduce cash costs, and maximise cash investment into the development – we are currently waiting on a response from them in regard to their capacity as covid lockdowns in 2020 have provided significant project delays.

Maangart Yorga Program

Shire of Goomalling was awarded \$19,605 to deliver the Maangart Yorga Program in partnership with Goomalling Aboriginal Corporation. The twelve-month program has been funded by Foundation for Rural and Regional Renewal (FRRR) and their sponsorship partner CCI Giving.

The program consists of workshops aimed to increase social participation and connection to culture; foster relationships across generations; enhance self-worth; provide a support network; develop skills for life that can be shared perpetually and could lead to sustainable income; improve health outcomes; and provide a safe space for social connection.

The last workshop was basic nutrition with Di Hutchison, Loving Larder. Participants learnt make quick, delicious, nutrient dense food that is cost effective for large homes. Participants feedback outline that they felt better informed about making food choices and were inspired to create healthier meals at home.

Monday 13th September

GREEN WASTE ONLY

The following items *WILL* be collected

- Only 2 cubic metres will be collected
- Tree and shrub prunings up to:
 - 1.5 metres in length
 - 350mm in diameter

The following will *NOT* be collected

- Leaves or lawn clippings
- Bags or boxes of leaves of grass clippings
- Dug out lawn
- Branches exceeding 1.5m length and 350 diameter
- General waste, junk or whitegoods

Tuesday 28th September

GENERAL WASTE ONLY

The following items *WILL* be collected

- Only 2 cubic metres will be collected
- Metals and white goods (fridges, stoves, electrical items)
- Bulk general waste
- Old furniture
- Mattresses
- TV screens and computer equipment

The following will *NOT* be collected

- Green waste
- Food waste
- Car bodies, vehicle parts, batteries, tyres, paint, chemicals or gas bottles
- Bricks, sand, cement or building rubble
- Asbestos or super six products

Other guidelines

- Only rubbish **on the verge** will be collected. Our staff will not be entering your property.
- Place your waste neatly on your own verge prior to the collection date.
- Keep an eye on your waste pile as it is your responsibility throughout the collection.
- Please have your waste on the verge **by 7am** the day of collection.
- Please do not put your waste out longer than 3 days prior to rubbish collection dates.
- Any waste that is too good for landfill will be given to the Goomalling Tip Shop for repurposing. Please leave these in a separate pile.

Rates and debtors

Are you having trouble paying your accounts or rates?

The Shire of Goomalling is committed to working with debtors and ratepayers to find an appropriate payment solution that works for both parties. Council understands that it can be difficult to ask for support, and will treat you with sensitivity, respect and confidentiality.

If you are experiencing difficulty paying your accounts or rates, please contact our Finance Officer Trudi Manera so we can help you make alternative arrangements and avoid interest, late payment fees and any further distress.

Pensioner rebate

Concession holders/Pensioners are required to pay their portion of the 2021/22 rates by 30 June 2022 in order to receive the rebate for 2021/22. Please remember to provide us with a copy of your **new** card when you receive it. **All rubbish and recycling charges must be paid in full and cannot be deferred.**

We review concession eligibility annually to ensure you are receiving the correct rebates. If you think you may be eligible for a concession or rebate, please contact Finance Officer Trudi Manera on 08 9629 1101.

Ratepayers & debtors

Please ensure you use the appropriate reference on internet banking transfers to ensure your payment is allocated correctly. This is either the **Debtor Code** or **Rates Assessment Number**, both are located on the top right hand corner of the invoices/notices.

How rates are calculated

Rates

GRV and UV:

The Valuer General (VG) provides all Local Governments with a Gross Rental Value (GRV) for each property within the Goomalling, Konnongorong and Jennacubbine Townsites. All other properties within the shire are given an unimproved Value (UV).

If you do not agree with this value, you have the option to contact Landgate to apply for a revaluation 08 9273 7373 www.landgate.wa.gov.au/valuations.

Rate in the Dollar (RID)

Local governments are responsible for setting the rate in the dollar for each land category which is then applied to the values provided by the VG. The Goomalling Shire Council sets the current year rate in the dollar for each category at the Annual Budget Meeting. Regulations state that these rates in the dollar are to be advertised publicly to enable any person to submit their response within 21 days to the local government.

- To calculate the actual rates charge, you multiply the GRV or UV value by the rate in the dollar.
 - Eg. If the UV value = \$100,000 and the RID = 0.76cents, then for every \$1 of unimproved value you will be charged 0.76 of a cent in rates as follows: 100,000 x .0076 \$760.00

Sewerage

- Sewerage is calculated in the same manner as above but using the GRV. This is because only properties in the townsite of Goomalling that have access to the deep sewerage are charged sewerage rates. Again it is based on the value and multiplied by the RID.
- If your residential, commercial or industrial property has a septic system instead, then you will not have a sewerage charge on your rate assessment.

Emergency Services Levy

- All non-exempt properties that are situated **outside** the townsite of Goomalling are charged an arbitrary Emergency Services Levy (ESL), set each year by the Department of Fire and Emergency Services (DFES). In 2021-2022 the ESL minimum charge is \$88.
- Properties within the townsite of Goomalling are charged an ESL based on the rate in the dollar set by DFES which is then applied to the Gross Rental Value set by the Valuer General. There is a minimum charge that applies. In 2021-2022 the minimum charge is \$88.

Mosquito fogging

Weather conditions permitting, Council will be fogging Tuesday and Thursday evening commencing Tuesday 31st August, until further notice in the Goomalling town site.

All residents are advised to keep clear (including pets) of fogging mist while outdoors.

What's happening in the works department

With the consistent rainfall, the majority of road projects have been on hold until they are dry enough to work on.

The rain, while beautiful, has been providing some significant challenges with erosion due to flooding. Culvert, gravel shoulders and unsealed roads have taken a heavy hit. Council staff are rectifying damage as soon as possible.



Long Forrest Road

Tree pruning, reconstruction of sub base and gravel re-sheeting (150mm compacted) has been carried out on Long Forrest Road (3kms). The roller is pictured above completing works.

Railway Terrace – Funding for design

Department of Transport has approved funding for a detailed design of Railway Terrace to include an on road cycle lane and solutions to slow vehicle traffic, creating a safer environment for both cyclists and pedestrians.

Main Roads WA have rejected the idea of on road cycling due to the addition of slip lanes and narrower lanes on Railway Terrace since the reseal.

Council is currently applying for funds to be transferred to the High Street budget which has increased in cost significantly since application to the concrete pricing.

Quinlan Street, although a higher priority cannot be considered without an application in a round. Council will look at applying in the next round of WABN funding as it becomes available.

Parks, Gardens & Ovals

Finals fever has taken over at the ovals with staff preparing the fields and additional requirements for the Mortlock winter sports finals which were held in Goomalling.



Building maintenance & plumbing

Nic is always busy tinkering, the pump station and Imhoff tank maintenance takes up significant amounts of time. The caravan park sewerage system was challenged with a continuous flow of traffic.

Hockey goals were refurbished to replace the broken plywood backboards with rubber for longevity and safety.

Repairs were carried out on the Opshop awning which had been leaking, it has been refurbished with new tin and silicon to prevent further leakage.

Jennacubbine Hall had minor maintenance and clean-up carried out prior to the scheduled Melbourne Cup event, which was later cancelled.

Water Tanks

Council installed two new 250KL water tanks at the Recreation Centre that will be connected to the existing reticulation infrastructure to supply scheme water in the case of drought/lack of supply from Council's non-potable sources. The project is possible thanks to the Goomalling Football Club Inc which obtained an Election commitment of \$50,000 from the Labor Government and our local member Hon Darren West MLC.
