



Summary

For Council to consider a proposal for a new rail siding adjacent to the CBH facility at Konnongorring.

Background

The existing Konnongorring CBH facility includes rail loading facilities, which have been operating at capacity for a number of years, resulting in delays and inefficiencies along the main rail line.

The Shire has received a Development Application from CBH Group for a new rail siding adjacent to their handling and storage facilities at Konnongorring. The Development Application proposes to remove a portion of the existing rail siding and facilitate the development of a new rail siding track closer to CBH's landholding (Lot 300), to alleviate delays on the mainline.

The new rail siding is located within sections of rail reserve, unmade road reserves, Lot 10 and a portion of CBH's landholding (Lot 300) in Konnongorring. The application area covers a total of 34.2 hectares across a number of land parcels.

The application proposes to upgrade the existing rail siding as outlined in Attachments 1, 2 and 3 to this report. In summary, the proposal includes the following:

- A new 1.15km rail siding within the rail reserve corridor and the eastern portion of Lot 300;
- Removal of a portion of the existing rail siding;
- A new rail maintenance access track along the western portion of the rail reserve boundary;
- The clearing of 0.16 hectares of remnant (native) vegetation;
- Temporary turnout installation pads and laydown areas; and
- · Associated earthworks and drainage.

Separate to the Development Application, a component of the proposed rail siding works are located within the area defined as 'Corridor Land' under the *Rail Freight Systems Act 2000*. These works are considered as 'public works' in accordance with section 6 of the *Planning and Development Act 2005* (Act) and therefore exempt from Development Approval under the town planning scheme. Attachments 1 and 4 to this report provide background.

The Development Application only seeks Development Approval for the works located outside the 'Corridor Land' (Development Approval Area) shown on the Context Plan (Attachment 2). The following works are subject to the Development Application to be determined by Council:

- A 0.56km portion of rail siding within the rail reserve corridor and the eastern portion of Lot 300;
- Two sections of maintenance access track along the western portion of the rail reserve boundary;
- A contractor laydown area within the portion of unmade road reserves between Lot 300 and the rail corridor; and
- Associated earthworks and drainage works.

The applicant has submitted the following technical reports and plans in support of the application:

- Detailed Design Plans (BG&E Resources);
- Site Context Plan (CLE Ref. 3244-76H-01);
- Environmental Memo (CBH);
- Drainage Design Report (BG&E Resources); and

4 m Chaster

Rail Noise Impact Assessment Report (SLR).

Due to the size of the documents, the technical reports are not attached but can be made available to Councillors upon request.

A portion of unmade road reserves (vested with the Shire) are included with the Development Application. This is because the proposed rail siding, associated maintenance access track

crosses through this section of unmade road, connection to an existing drainage culvert and use of the land as a temporary laydown area for construction. The use of this land was considered by Council, at its 17 May 2023 Ordinary Meeting, where it resolved the following at Resolution 636:

'That the Council:

- 1. Advise the proponent that Council has no issues with the proposed use of the unmade road reserve as for construction laydown purposes during the construction phase of the project.
- 2. Has no issues with the proposed rail siding and associated access track crossing the unmade road reserve at the Konnongorring site.
- 3. Agrees to the proposal to re-site the road closed signage referred to in the proposal.
- 4. Delegates authority to the CEO to sign the Development Application for the project on Councils behalf as the owner/controller of subject land.'

Once constructed the rail siding will be owned by the State Government and managed and maintained by Arc Infrastructure.

Consultation

CBH has consulted with relevant stakeholders.

The current Development Application has not been subject to community and stakeholder consultation. It is a discretionary decision of Council whether or not to undertake advertising on the Development Application. Noting the existing rail siding and the proposed works are located no closer to nearby residences, the Shire administration suggest that no advertising is required for this Development Application.

Statutory Environment

Planning and Development Act 2005
Planning and Development (Local Planning Schemes) Regulations 2015
Shire of Goomalling Town Planning Scheme No. 3 (TPS3)
Local Government Act 1995

Land ID 4090928 & 3123951 are reserved as 'Railway Purposes' in TPS3. The objectives for 'Railway Purposes' is 'to set aside land for railway and other authorised purposes.' The proposed rail siding satisfies the objectives of TPS3 and reflects the purpose of the 'Railway Purposes' reserve by facilitating the efficient movement and loading of grain which supports farming and rural pursuits in Konnongorring and its surrounds.

Lot 300 is zoned 'Rural 3 – General Farming' in TPS3. TPS3 objectives for this zone include to maintain the rural economy of the Shire, protect the rural landscape and environment generally and 'to ensure minimal intrusion onto the rural landscape and the amenity of adjoining properties.' The minor rail incursion into Lot 300 and the associated earthworks design, does not affect the viability of rural pursuits on CBH's landholding.

The applicant has not as yet paid the Development Application fee as this is subject to negotiation as a significant part of the works are potentially exempt as public works. The applicant has a right of review to the State Administrative Tribunal to review the Council's decision. If this occurred, the Shire would have associated costs.

Comment/Conclusion

The Development Application proposes a major redevelopment to support the Konnongorring CBH grain facility.

The Public Transport Authority and CBH are of the view that the works within the 'Corridor Land' are consistent with the matters raised in section 6 (2) (a) and (b) of the Planning and Development Act 2005. It is suggested the applicant's letter satisfies section 6 (3) of the Act given consistency with TPS3 and that the works address orderly and proper planning.

It is recommended that Council conditionally approve the Development Application given:

- The rail siding is existing and the improved rail siding will assist to lower heavy vehicle use;
- It proposes an upgrade to the rail network which supports a more efficient and productive local agricultural industry;
- It is consistent with the current use of the land and will provide a significant increase in storage and fast rail loading that will ease the strain on the road transport system;
- It is consistent with the planning framework;
- The Rail Noise Impact Assessment Report demonstrates that the new rail siding will meet the requirements of State Planning Policy 5.4 Road and Rail Noise and the Environmental Protection (Noise) Regulations 1997;
- The Drainage Design Report demonstrates that the proposed drainage infrastructure can adequately accommodate convey site and upstream run of without any impact to the existing main rail line or any other surrounding infrastructure or properties;
- The Environmental Memo confirms there is no evidence of breeding and foraging habitat for the Carnaby's Black Cockatoo and no threatened or priority flora species recorded;
- The Aboriginal Archaeological and Ethnographic Assessment found no new Aboriginal heritage sites (archaeological or ethnographic) within the survey area. The Ballardong representatives gave their consent for the project to proceed across the survey area;
- The proposed rail siding is not expected to create significant additional impacts on the amenity of the area;

Grants development approval to CBH Group for a new rail siding on various land parcels at Konnongorring (outlined in Attachment 11.1.1), subject to the following conditions:

- 1. This approval shall expire if the development hereby approved has not been substantially commenced within a period of three years from the date hereof, or within any extension of that time (requested in writing prior to the approval expiring) that may be granted by the local government. Where the Development Approval has lapsed no further development is to be carried out.
- 2. The development hereby approved must be carried out in accordance with the plans and reports submitted with the application, addressing all conditions, or otherwise amended by the local government and shown on the approved plans and these shall not be altered and/or modified without the prior knowledge and written consent of the local government.
- 3. The Drainage Design Report to be implemented and maintained to the satisfaction of the local government.
- 4. The applicant/operator to implement dust control measures to the satisfaction of the local government on an on-going basis.
- 5. Any lighting devices are to be positioned and shielded so as not to cause any direct, reflected or incidental light to encroach beyond the property boundaries, in accordance with *Australian Standard AS4282/1997*.
- 6. Within 6 months of the proposed upgrade being completed, the applicant/operator to commission a short term noise monitoring survey to confirm operational noise levels at nearby receivers and to undertake mitigations measures as required to the satisfaction of the local government. Following this, to commission a short term noise monitoring survey if there are any sustained noise complaints received and to undertake mitigations measures (as required) to reduce impacts on nearby receivers to the satisfaction of the local government.

Advice

- A) The applicant/operator is encouraged to review noise levels through construction.
- B) If the applicant is aggrieved by this determination there is a right of review by the State Administrative Tribunal in accordance with the *Planning and Development Act* 2005 Part 14. An application must be made within 28 days of the determination.

As part of the 2023/2024 Budget the Council made provision for all staff to have a 5% pay increase. This included the CEO whose increase only takes effect following a determination through the performance review process as at his anniversary date in September.
