

Nature of Council's Role in the Matter

Purpose of Report

Council to seek the Shire of Toodyay to submit its recommendation to the Minister for Local Government to change the boundary between the Shires of Goomalling and Toodyay along the 5.39km section of Bejoording Road from the eastern side of Bejoording Road to the western side to correct the anomaly which has been in existence since the establishment of the district of the Goomalling Road Board in 1895.

Background

As stated above, the anomaly has been in existence since 1895 as both Local Governments of Goomalling and Toodyay including Main Roads WA have this section of road within the Shire of Goomalling. The fact is proven by both Shires and MRWA depicting this section of road being the responsibility of the Shire of Goomalling. This is confirmed by the fact that whenever problems on this section of road were reported by members of the Toodyay public and the Shire of Toodyay for repairs or immediate attention, the Shire of Goomalling never shirked its responsibility and always carried out immediate maintenance work and in the last six (6) years has been carrying out reconstruction work widening Bejoording Road from a 6 metre width seal to a 7 metre width seal to accommodate heavy haulage traffic. As the re-construction work is nearing completion, the Shire of Goomalling now seeks the Shire of Toodyay to submit to the Minister recommending the Governor to make an order to relocate the boundary of the Shires of Goomalling and Toodyay from the eastern side of Bejoording Roads to the western side for the mentioned 5.39km section of this road.

Comments and details

It is my recommendation that Council seek the Shire of Toodyay to submit its recommendation to the Minister for Local Government recommending the Governor to make an order to relocate the boundary of the Shires of Goomalling and Toodyay from the eastern side for the mentioned 5.39km section of Bejoording Road to reflect what has been in existence since 1895.

Implications to Consider

Strategic

To correct an anomaly since 1895 as Council never shirked its responsibility to maintain and reconstruct this section of road.

Policy Related

There is no Policy of Council appertaining to this matter other than the decision being made by Council.

Financial

No additional costs as road costs have always been borne by the Shire of Goomalling.

Legal and Statutory

This process is required under Section 2.1 (2) and Schedule 2.1 Clause 2 (1) (c) of the Local Government Act 1995.

Risk

It is viewed that the main risk would be where the Shire of Toodyay rejected Council's request. However, it is very unlikely that this would occur as the Shire of Goomalling has always maintained this section of road since 1895 as depicted in both Shires' Road Inventories including the Roads Inventory of Main Roads WA for all local governments in the Wheatbelt. This Council has never shirked its responsibility of maintaining this road at all times.

Nature of Council's Role in the Matter

Executive Legislative

Purpose of Report

At a previous Council Forum held in September 2016 Cr Chester raised the consideration with Councillors of acquiring a second hand 12/14 Seater Community Bus to provide our community with the choice of buses depending on the number of passengers who require travel to and from travel destination and return respectively. Cr Chester indicated that B & V Brookes' school bus was being traded to allow for a new school bus for their usage. Authority was given to the CEO to commence negotiations.

Background

Initial discussions with Mrs Veronica Brookes advised that the purchase price for the bus was \$12,000 with Council's counter offer of \$8,000 being made to her. As Council is aware Mrs Brookes came back with a final offer to purchase for \$10,000. The Toyota 14 seater school bus was built in 2005 and has travelled in excess of 220,000km. The market value of the vehicle is around the \$10,000 valuation.

Comments and details

Although Council has not allowed the item of expenditure in its 2016/2017 budget document, Council may proceed to purchase as the figure may be provided from the following savings:

Budget Expend for Int. on Overdraft \$5,000 Budget Revenue for Int. on Invest \$5,125.

It is calculated that the expenditure on Interest on Overdraft will be very minimal most likely to be zero with in excess of \$10,500 to be received in Interest on Investments. Normally Council would invite tenders or quotes for this type of consideration, however it is viewed by Council that the opportunity "is too good to miss" and considers that this purchase is strategic and financially beneficial to Council and the Community.

Implications to Consider

Strategic

As indicated above, Council's view is the opportunity "is too good to miss" and consider that the acquisition of the Toyota 14 Seater bus is not only strategic but will provide financial benefits to Council and the Community.

Purpose of Report

For Council approval to appoint Environmental Health Officer, Mr Linton Thomas as the Designated person to administer provisions of the Public Health Act 216, The Health (Miscellaneous Provisions) Act 1911 and a range of other relevant Health Related Acts in the Shire of Goomalling.

Background

The new *Public Health Act 2016* was proclaimed in July 2016 and is to be implemented in 5 stages over a period of 3-5 years.

Stage 1 & 2 have been completed by the Department of Health and the Environmental Health Directorate (Department) is setting up stage 3 which will have impact on Local Governments. This will start on the 24th January 2017.

Comments and details

It involves confirming the appointment of the current Environmental Health Officer to be the designated person to administer the Public Health Act 2016 and the Health Act (Miscellaneous Provisions) Act 1911, which is the old Health Act of 1911, in the Shire of Goomalling.

The Health Act (Miscellaneous Provisions) Act 1911 and subsidiary legislation will continue to be the main enforcement tool for local government during stages 3 and 4.

In order to minimise the impact on local governments, Section 312 of the *Public Health Act 2016* includes a transitional provision. Under that section, persons who are currently appointed as EHO's will be deemed to be designated as authorised officers for the purpose of the *Public Health Act 2016*, the *Health Act 1911* and a range of other relevant Acts.

Nature of Council's Role in the Matter

Executive

Purpose of Report

To approve the purchase and installation of three (3) water coolers.

Background

Previously a water cooler was located at the tennis courts but had been taken away because of vandalism. Due to the recent construction of the BMX track, the request for readily available water has increased from the community. The Goomalling Bowling Club requested the Shire's permission to install a water cooler at their expense at the new Bowling Green however asked the Shire to research potential types. To reduce the attraction of the cooler near the Bowling Green, a third water cooler should be installed near the old pavilion for gym and oval users.

Comments and details

In accordance with the Shire of Goomalling's Disability Access Plan, at least one of the water coolers should be disability access friendly.

Implications to Consider

Water coolers tend to attract youth and can be the target of vandals. In considering the type of coolers, the material needs to be at least vandal resistant and tough enough to withstand any type of impact.
