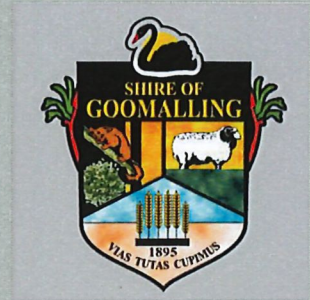

Summary

For Council to consider a Report of Review of the *Shire of Goomalling Town Planning Scheme No. 3*.

Background

The *Shire of Goomalling Town Planning Scheme No. 3* (TPS3) was gazetted on 14 July 1995. TPS3 is no longer fit-for-purpose including supporting economic development and economic diversification. A new Local Planning Scheme No. 4 (LPS4) is required to be prepared.

The *Planning and Development (Local Planning Schemes) Regulations 2015* (to be called the 'Regulations') require that every five years, following publication of a Scheme in the Government Gazette, the local government is to prepare a report on the operation of the Scheme to the Western Australian Planning Commission (WAPC). An extract of the Regulations is outlined in Attachment 1.

The Regulations require that the Report of Review must include a recommendation as to whether the Scheme:

1. Is satisfactory in its existing form;
2. Should be amended; or
3. Should be repealed and a new scheme prepared in its place.

A Report of Review of TPS3 has been undertaken and is outlined in Attachment 2.

Consultation

Preliminary liaising has occurred with the Department of Planning, Lands and Heritage (DPLH). Should the WAPC agree that TPS3 is to be replaced with a new Scheme and that an associated Local Planning Strategy is required, these will be subject to community and stakeholder consultation.

Nil at this stage. Subject to the WAPC's decision, there will be future costs in replacing TPS3 with LPS4 and in-time preparing a Local Planning Strategy.

Comment/Conclusion

The Report of Review concludes that TPS3 is outdated and a new LPS4 is required. LPS4 would:

Align the Scheme structure and content and mapping with the Model Scheme Text and Deemed Provisions of the Regulations; including model zones and reserves and land uses to ensure a contemporary planning framework is in place;
Update zone-specific and general development provisions consistent with the State Land Use Planning Framework to introduce contemporary planning controls that address land use and development issues including short-term rental accommodation, workforce accommodation, additional dwellings on Rural zoned land, telecommunications and development on lots abutting unconstructed roads;
Support economic development and job creation including enabling consideration for a greater range of land uses in different zones;
Assist to provide increased housing to intentionally address, or mitigate against, the potential for population declines as set out in the WAPC's *Western Australia Tomorrow* population projections; and
Set out supplementary development exemptions, where no development approval is required, to those already in the Deemed Provisions under the Regulations.

It is suggested LPS4 would set out modest changes compared to existing TPS3 maps. The main expected changes are:

Changing zone and reserve names to reflect the Regulations;
Reducing the number of zones including Fuel Depot and Service Station; and
Reducing the three Rural zones to one Rural zone.

The Shire does not have a Local Planning Strategy. The Local Planning Strategy would:

Align the local planning framework with Shire of Goomalling's *Strategic Community Plan*;
Identify planning issues and provide long-term planning directions and actions to manage the land use change and development within the Shire over the next 15 years;
Apply any State or regional planning policy that is relevant;

Provide the rationale for more substantial changes to zoning or classification of the land under the local planning scheme; and
Identify requirements for additional land for residential, industrial and commercial purposes.

It is proposed that preparation of the Local Planning Strategy occur in the medium-term following finalisation of LPS4. Following the WAPC approving the Local Planning Strategy, it is expected there will be amendments to LPS4. For instance, subject to consistency with the Local Planning Strategy, this could include a scheme amendment to increase the amount of Industry zoned land in a suitable location near the Goomalling townsite.

Following the Council's decision on the Report of Review, the WAPC will review the recommendations in the Report of Review and will decide whether it agrees or disagrees with the recommendations. Assuming the WAPC support the Report of Review, the Shire administration will prepare items to Council to formally commence the process of preparing LPS4 to address the Regulations.

11. WORKS REPORTS

11.1 Works Manager Report

Calingiri – WSN

The existing sealed pavement has been removed, pavement width widened out to 10m with the sub grade compacted. A 150 mm compacted gravel sheeting basecourse overlay is occurring. Sub grade cement stabilisation has been completed on 41 000 m2 which was identified from Geo Technical surveys being completed.

All works are being completed between SLK 24.40 and 30.00.

Plant –

Water Truck –

The truck has received damage to the front of the cab. The truck is currently at City Panel Beaters for repair quoting and insurance company inspection. Updated details will be given as the information arrives.

Steel Roller –

Has a major oil leak suspected from the pump drive motors. Two mechanical companies have been engaged to inspect and provide quotes for repairs. Updated details will be given as the information arrives.

Doctors Surgery Generator -

Fuel pump issues have been found which is causing pressure to be lost and starting issues occurring. It is currently not automatically starting due to shut down issues but at this point can still be started manually. A mechanical company has inspected the fuel pump with further repairs to occur as soon as possible.

Council meeting works -

High Street –

Works are scheduled on the unsealed shoulder of High and James Street.

This area has loose gravel and minor wash outs and may impact motorised access to the footpath entrances. Levelling and laying of cold mix to seal will occur as soon as materials and staff availability can be sourced.

60A Forrest Street –

Works scheduled to clean out drain and upgrade if possible.

Meckering Road –

Small pothole at the junction of Saddler Road has been repaired.
