The existing sealed pavement has been removed, pavement width widened out to 10m with the sub grade compacted. A 150 mm compacted gravel overlay basecourse has been completed.

Basecourse cement stabilisation has been completed on 58 000 m². Prime sealing will occur in the 2025/26 budget year when weather conditions permit.

All works are being completed between SLK 24.40 and 30.00.
