

Purpose of Report

Dr Susan Gordon, Chairperson Sister Kate's Children, wrote to the following Ministers: -

- Hon Ben Wyatt, Treasurer and Minister for Aboriginal Affairs,
 - Hon Mick Murray, Minister for Sport and recreation,

seeking financial support for Miss Karri Roeburne who was invited by the NSW Bush Rangers to tour Japan to play hockey during this month.

On receipt of Dr Susan Gordon's letter to the two (2) Ministers, Dr Lesleigh Hayes who works in the Department of the Premier and Cabinet rang me to gauge if there would be any financial assistance available from the Shire of Goomalling. Lesleigh was advised to forward all relevant correspondence to me as time was of the essence.

Background

As detailed above in Purpose of the Report, Karri Roeburne was invited by the NSW Bush Rangers to tour Japan to play hockey over two weeks this month. The cost of the tour is \$5,578 and is beyond the reach of the family. Relevant correspondence was sought from Dr Lesleigh Hayes who submitted the attached details.

Karri has been playing hockey since 5 years old for Minkey in Goomalling, continuing until she moved to Northam in 2011 where she played both junior and senior hockey across the Mortlock and Avon Districts Hockey Associations. Karri continues to excel as a hockey player hence her invitation to tour Japan in April 2018.

Nature of Council's Role in the Matter

Executive Legislative

Purpose of Report

Due to items of expenditure being either not budgeted for or over expended in 2017/2018, an amount of \$100,000 from Council's Investment Reserve of \$1,000,000 is required to be executed by Council thereby reducing Council's investment down to \$900,000 on the 30th June 2018.

Background

Three (3) Reserve accounts namely Plant, Long Service Leave and Aged Care require adjustments to accommodate Council's items of expenditure being either not budgeted for or over expended in 2017/2018. The reserve Accounts and amounts to be withdrawn are detailed as follows: -

Plant Reserve Account	\$ 40,000
Long Service Leave Reserve Account	\$ 35,000
Aged Care Reserve Account	<u>\$ 25,000</u>

Comments and Details

Council's Investment Reserve of \$1,000,000 which is invested in Bendigo Bank's Term Deposit matures 30th June 2018. Reducing the Term Investment by \$100,000 will allow Council to re-invest \$900,000 for another term of 12 months to 30th June 2019.



The reasons behind the need to transfer the mentioned amounts are detailed as follows: -
