

Purpose of Report

Council is requested to write-off of the rate and penalty interest by absolute majority as per Section 6.12 of the Local Government Act 1995.

Background

In April 2016 two (2) advices of sale were received via Landgate requesting all but one (1) location, being Avon Loc 26285 a small land area measuring 2.2 Hectares, of A373 to be sold to two (2) separate parties. The transfer was effected by subdividing the original A373 into 3 new assessments being A1318, A1319 and A1320 with new valuations for them sought and received from Landgate.

The remaining Avon location 26285 (A1318) was recorded in the name of the original landholder. Subsequently minimum rates were raised in July 2016 but they remained unpaid.

When contacted, the original landholder advised that all the locations of the original parcel in A373 were sold hence they no longer had any landholdings in the Shire of Goomalling.

The original paperwork was revisited and a call was made to the landholder's settlement agent, WA Property Lawyers, who confirmed that all locations should have been transferred in the sale and that they had made an error by omitting Loc 26285 from the Advice of Sale document.

An amalgamation of A1318 and A1320 was then sought to combine the landholdings into the one (1) assessment A1348 as was originally intended. A new valuation was issued via Landgate and rates were raised to reflect this change.

Therefore, the amount of rates outstanding in A1318 (Avon Location 26285) require writing off as they have been raised in A1348 and were paid in November 2017.

The outstanding balance is \$1007.99 and is made up of the following:

Legal and Statutory Environment

Council is bound by the Local Government Act 1995 as follows:

Section 6.12 of the Local Government Act 1995

- 6.12. Power to defer, grant discounts, waive or write off debts
 - (1) Subject to subsection (2) and any other written law, a local government may —
 - (a) when adopting the annual budget, grant* a discount or other incentive for the early payment of any amount of money; or
 - (b) waive or grant concessions in relation to any amount of money; or
 - (c) write off any amount of money,
 - (d) which is owed to the local government.
 * By absolute majority

Financial Implications

The result of the write off will be a reduction of income as follows:

- Reduction of rates arrears income by \$1003.50
- Reduction in penalty interest arrears of \$4.49.

The definition of an asset requires a future economic benefit, and, given these rates were raised in error, the account is neither valid nor recoverable hence there is no future economic benefit. As such it would be incorrect to continue reporting this amount as an asset, hence the balance sheet will be affected as follows:

Purpose of Report

To authorise the affixing of the Common Seal to the Schedule "B" Goomalling Public Cemetery Form of Grant of Right Burial, Grant No. 116 for Kenneth & Barbara Slater's tenure of Grave No. 37 in the Roman Catholic section.

Background

In simple terms, a Grant of Right of Burial, or, Grant, is the tenure agreement over a stated burial plot which confers upon the holder of the Grant, known as the Grantee, the right to conduct burials, inter ashes and erect a monument within the burial plot.

Under the 1986 Act, the maximum guaranteed tenure on any given plot is 50 years although this is able to be extended for further 25 year periods at the discretion of the managing cemetery authority.

Extensions can only be in 25 year increments.

Nature of Council's Role in the Matter Executive Legislative

Purpose of Report

To endorse the affixing of the Common Seal of the Goomalling Shire Council to the Lease Agreement between the Shire of Goomalling and the Mortlock Sports Council at Goomalling Sport & Community Centre at the Goomalling Recreation Grounds.

Background

Since Mortlock Sports Council (MSC) commenced utilisation of the Goomalling Sport & Community Centre (GSCC) in 2015, discussions have been ongoing between MSC and the Shire of Goomalling to agree on the conditions of the lease.

Mortlock Sports Council have contributed \$10,000 to the installation of solar panels at the Goomalling Sport & Community Centre in 2017, and it was agreed that the Shire of Goomalling pay all electricity charges.

The lease documents have now been signed by both parties, therefore, the common seal can be affixed to finalise the lease.
